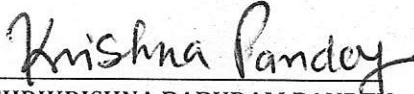

નવી દિલ્હી, તા. ૯ એનસીપી (એસીપ)ના વરિષ્ઠ નેતા અનિલ દેશમુખે આજે કેન્દ્ર અને મહારાષ્ટ્ર સરકારને બાંગ્લાદેશમાં ચાલી રહેલી અશાંતિ વચ્ચે વિદર્ભ સંતરા અને અગ્રણી આયાકર્તાને આ ફળની નિકાસ અંગે યોગ્ય પગલા લેવાની અરજ કરી છે. રાજ્યના નારંગી પટ્ટાના કોટીલાન ધારાસભ્ય દેશમુખે જણાવ્યું હતું કે નારંગી અને સંતરાના ઉત્પાદકોએ નવેમ્બરમાં લણણીમની મોસમ દરમિયાન તેના ઉત્પાદનના સારા ભાવ ન મળવાથી ચિંતિત હતા. કેન્દ્ર અને રાજ્ય સરકારઓએ વિદર્ભથી બાંગ્લાદેશ, કુવૈત, ઓમાન, અમેરિકા, ચીન, હોંગકોંગ અને ઓસ્ટ્રેલિયામાં મોકલવામા આવતા સંતરા અને મોસંબીની નિકાસ અંગે યોગ્ય પગલા લેવા જોઈએ, તેમ તેમણે એક અહેવાલમાં જણાવ્યું હતું.
