NOTE: We have received an email regarding the resignation of the auditor on 30th December, 2024 but the details required under Regulation 30 of SEBI LODR Regulations received from an Auditor on 4th January, 2025. As per SEBI Circular CIR/CFD/CMD1/114/2019 dated 18th October, 2019, If the auditor resigns after 45 days from the end of a quarter, they must issue the limited review or audit report for the current and next quarters before resigning. But the Statutory auditor refused to issue limited review report for the quarter ended 31st December, 2024.

2. Resignation of Mr. Nihar Gaurang Sheth (DIN: 10308024) has tendered his resignation as an Independent Director of the Company, with effect from close of business hours on January 05, 2025.


