What % of carts in Marina can be given to PwDs: HC

Disabled persons sought 5% pushcarts that will be given under beautification scheme

THE Madras High Court has instructed the Greater Chennai Corporation (GCC) to inform the court within two weeks as to what percentage of the total number of smart pushcarts can be allocated for persons with disabilities (PwD) to run business on Marina Beach.

The direction was issued by a division bench of Justices R Suresh Kumar and AD Jagadish Chandra on Friday while hearing a batch of petitions relating to the allotment of smart pushcarts, stalls in the fish market at Marina Loop Road and demarcation of vending zones.

The persons with disabilities had approached the court seeking allocation of 5% of the 900 pushcarts, which are going to

be distributed under a beautification scheme.

Regarding the allotment of stalls in the newly constructed fish market, Additional Advocate General J Ravindran informed the court that 356 vendors were identified and of them, 64 were issued tokens for allotment. Since a temple festival is under way in the locality, the allotment process could not be carried out, he said, adding that, however, the allotment would be completed in two weeks.

Meanwhile, the high court directed the Greater Chennai Corporation to submit a report within two weeks on the announcement of vending zones and non-vending zones in the city limits.

The court's direction was given on a petition filed by N Rukmangathan.

64,217 cops deployed across state for Vinayagar Chaturthi celebrations

THE state police have made elaborate security arrangements to ensure a peaceful Vinayagar Chaturthi festival from Saturday, an official statement said.

As many as 64,217 police personnel have been deployed for regulating traffic and maintaining peace and order during installation and immersion of idols. In Chennai, the police

have given permission for the installation of 1,519 idols.

In view of the movement of a large number of people from Chennai to their native places across the state, elaborate arrangements have been made for regulating the crowd at bus stands and ensuring the smooth flow of traffic on the GST and GWT roads, the statement from Tamil Nadu police said.

Immersion processions will be monitored through CCTV cameras and drones.

Processions at sensitive and hypersensitive routes/ places will be directly monitored from the TN Police headquarters through CCTV live streaming. The Vinayagar idols installed at different places will be GPS tagged on the SMART KAVALAR app for monitoring and supervision.

THE Tambaram City Municipal Corporation (TCMC) has intensified its dengue control measures, launching a series of targeted measures to combat the mosquito-borne disease.

TCMC Commissioner S Balachander, on Thursday, inspected several streets in Tambaram East and reviewed the ongoing dengue prevention activities. He outlined key initiatives being implemented, including regular fogging in mosquito-prone areas and the removal of stagnant water. Eight fogging vehicles have been deployed along with additional hand-held fogging machines to cover more areas efficiently. The commissioner warned that fines would be imposed on residents and commercial establishments that fail to keep their premises clean and free of mosquito breeding grounds.
