On April 18, 2024, Infosys Germany GmBH, a wholly-owned stepdown subsidiary of Infosys Limited, entered into a definitive agreement to acquire 100% of the equity share capital in in-tech Holding GmbH, leading provider of Engineering R&D services headquartered in Germany, for a consideration including earn-outs amounting up to EUR 450 million (approximately ₹4,045 crore), subject to customary

closing adjustments. Subsequently as on the date of these results, Infosys Germany GmBH has completed its acquisition of 100% of the equity share capital of in-tech Holding GmbH.

Information on dividends for the quarter ended June 30, 2024 For financial year 2024, the Board recommended a final dividend of ₹20 (par value of ₹5 each) per equity share and additionally, a special dividend of ₹8 (par value of ₹5 each) per equity share. The same was approved by the shareholders in the Annual General Meeting (AGM) of the Company held on June 26, 2024 and paid on July 1, 2024.
