5. The Company has appointed **M/s. MNB & Co. LLP**, Practicing Company Secretaries as Scrutinizer to scrutinize the e-voting process.
6. The result of the e-voting shall be published by the company Secretary of the company on Thursday, October 03, 2024.
7. Members desiring any information on the accounts of the Company are requested to write to the Company at least seven days before the date of the Meeting to enable the Company to keep the information ready at the Meeting.
8. Members who hold shares in dematerialized form are requested to write their Client ID and DP ID Nos. and those who hold shares in physical form are requested to write their Folio No. while login for attending the Meeting.
9. The Register of Members and Share Transfer Books of the Company shall remain closed from Tuesday, September 24, 2024 to Thursday, September 26, 2024 (both days inclusive) for the purpose of the Annual General Meeting and Dividend of the Company.
