# Dawood declared terrorist in individual capacity, says Bombay HC; grants bail to 2 UAPA accused

MUMBAI, JULY 20 -- The Bombay High Court said fugitive gangster Dawood Ibrahim has been declared a terrorist in his individual capacity under Unlawful Activities (Prevention) Act (UAPA) and, hence, any association with him or his gang would attract provisions of the stringent law. A division bench of Justices Bharati Dange and Manjusha Deshpande, in an order of July 11, details of which were made available on Friday, granted bail to two persons held by the Maharashtra Anti-Terrorism Squad in August 2022. The ATS had claimed Faiz Bhivandiwale, from whom it seized 600 grams of ganja, and Farves Vali, were members of Dawood Ibrahim's gang. The duo was booked under UAPA for being members of a terrorist organisation, committing terrorist acts and collecting funds for commission of an offence as well as under Narcotic Drugs and Psychotropic Substances (NDPS) Act provisions. In its judgment, the HC said the Union government had issued a notification on September 4, 2019, notifying Dawood Ibrahim as a 'Terrorist' under the UAPA.

The bench said UAPA has no retrospective effect of an individual, which would amount to a terrorist act on one hand, and the activities by the terrorist gang and terrorist organisation on the other. In our view, prima facie, the offence of Section 20 of the UAPA being members of a terrorist organisation would not be attracted, as Dawood Ibrahim Kaakar has been declared a terrorist in individual capacity, the court said. Therefore, any association with him on the pretext that a person belongs to D-gang/Dawood gang will not attract the provisions of Section 20. It added, the bench also said additional public prosecutor S V Gavand, on instructions from the ATS officer, made a statement that there was no material in the charge-sheet establishing the accusations under UAPA sections 17 and 18, which pertain to committing a terror act and collecting funds for commission of an offence. The HC also said the contraband allegedly seized from one of the accused was a small amount. The court released the duo on furnishing a personal bond of Rs 50,000 each. (PTT)

NEW DELHI, JULY 20 -- Union minister and LJP (Ran Vilas) chief Chirag Paswan has pitched for a nationwide caste census but warned against making the figures public as it will lead to "division" in society and said no discussion within the ruling NDA has taken place so far over simultaneous polls and the Uniform Civil Code, both part of the BJP's manifesto. In an interaction with PTI editors, he flagged concerns about the UCC and said he cannot take a position unless a draft on it is placed before him. He, however, asserted that his Lok Janshakti Party (Ran Vilas) strongly supports the concept of simultaneous polls. Asked about his views on the Uniform Civil Code (UCC) and if he supports it, Paswan said, "We don't have a draft for it yet. Until unless we go through that draft, because there are a lot of concerns... India is a country of diversities." De it language, culture or lifestyle, everything is different in different regions of the country, he said, wondering "how can you bring everyone under one umbrella". While the focus is often on the Hindu-Muslim issue in the debate on the UCC but it is about Hindus as well, as their practices and traditions, including those related to marriage, differ across the country, he added.

In Chhattisgarh, I think, tribals are being kept out of this. So how can you get them under this umbrella? So until and unless a draft comes, I don't think I will be able to answer the question," Paswan added. "It is not it about Hindu-Muslim divide. It is about getting everyone together," he said. Paswan said the caste census should be part of the next census as specific data is often needed for adequate allocation of money for development schemes. Courts also at times seek population data of different castes, he added. The third term Lok Sabha - BJP, however, asserted that the data must be kept with the government and not made public. "I am absolutely not in support of making it public. It only leads to division in society," he said, noting that new people in Bihar are being associated with the percentage of their caste in the total population after the State government disclosed the figures of its caste survey. Union Home Minister Amit Shah had said last year that census and delimitation will happen immediately after the new government comes to power. The Narendra Modi government returned to power for a third straight term in June. Though the BJP had supported the caste census in Bihar, the central government has so far not spelt out its stand on the Opposition's demand for a nation-wide headcount on caste lines. Asked if it would be possible for the NDA government, which has retained power with a reduced majority, to bring in the provisions for holding simultaneous polls in the country, Paswan said, "Yes, of course. With that, "One Nation, One Election" is something we and my party have supported very strongly. We had given our suggestions to the committee headed by former president Ram Nath Kovind. We are waiting for the final draft to come up for discussion," he said. (PTT)

## ED seizes over Rs 1-Cr cash, undisclosed assets during raids against Cong MLA, others

NEW DELHI, JULY 20 -- The Enforcement Directorate (ED) on Saturday said it has seized Rs 1.42 crore in cash, documents related to more than 30 "undisclosed" flats and land during searches against Haryana Congress MLA Rao Dan Singh, his son and some business entities as part of a bank-loan fraud-linked money-laundering investigation. The raids were launched on Thursday (July 18) in Mahendragarh and Gurugram in Haryana, apart from Delhi and Yamshedpur (Jharkhand), among the legislator, his family, a linked company called Suncity Projects Private Limited, another company called Allied Stripe Limited (ASL) and its promoters Mohan Agrawal, Agrawal Agrawal and some others. ASL manufactures cold roll steel products. The money-laundering investigation stems from a CBI FIR filed against the accused, who were charged with committing "fraud" by obtaining "loan" from banks, the criminal misappropriation, criminal breach of trust and cheating, and causing wrongful loss of more than Rs 1,392.86 crore to a consortium of banks led by the Central bank and other institutions led to the seizure of cash amounting to Rs 1.42 crore, incriminating documents about 32 undisclosed flats and land, various lockers, trunks etc. From the premises of the accused, the search operations failed to identify including entities of Akshat Singh, son of Rao Dan Singh, the ED said in a statement. It, however, did not specify what exactly was seized from where.

## Sex racket busted in Navi Mumbai, 8 women rescued

NAVI MUMBAI, JULY 20 -- The Navi Mumbai police have busted a sex racket with the arrest of an auto-rickshaw driver, an official said on Saturday. Police recently received a tip-off about a gang involving women to various lodges for prostitution after spotting customers online, said Inspector Prithviraj Gopande of the anti-human trafficking cell of Navi Mumbai police. With the help of a decoy customer, they recently nabbed the auto driver, identified as Pradeep Yadav, who used to ferry the women to hotels, the official said. The police first rescued a woman after Yadav's questioning on the information she provided. They rescued seven women from a room at Shrivriva in the Nerul area. They also arrested two men, identified as Vinu, alias Ashokumar Janki Yadav (28), and Indrajit Indrayadav (58) from there, he said. The suspected kingpin of the racket, Shambu Bhadhya, is at large, the official said. An FIR has been registered under the Bharatiya Nyaya Sanhita (BNS) at Turbhe police station, he added. (PTT)

## AAP protests near BJP office over cutting of 1,100 trees in Delhi's southern ridge

NEW DELHI, JULY 20 -- New Aam Aadmi Party (AAP) activists on Saturday staged a protest near BJP office on DDU Marg over alleged cutting of 1100 trees in Delhi's southern ridge area. The protesters, some of whom wore face masks of Delhi LG VK Saxena also carried out a sit-in of saws and tree stumps and formed a human chain. They alleged that the Lt Governor of BJP-led Centre was responsible for cutting of the trees in the protected forest area in the ridge. The Supreme Court which is seized of the matter of cutting of trees in the Ridge in Southern Ridge has come down heavily upon both LG VK Saxena and the AAP government. The AAP has alleged that the trees were cut for a road widening project by the Delhi Development Authority (DDA) on the "verbal instructions" of the LG. The BJP has alleged that the trees were cut after approval of Delhi Chief Minister Arvind Kejriwal and Environment minister Gopal Rai. (PTT)
