Kindly take the same on your records.

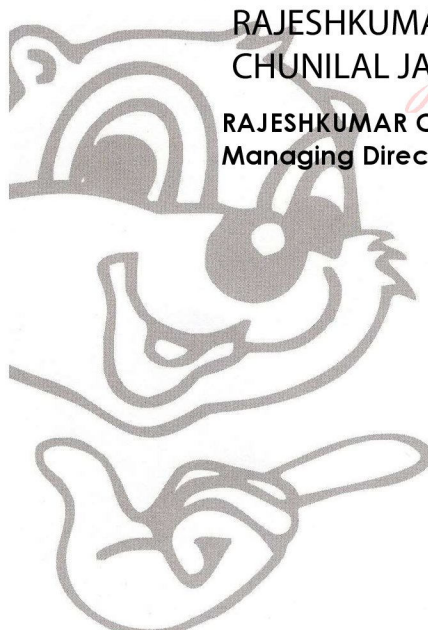

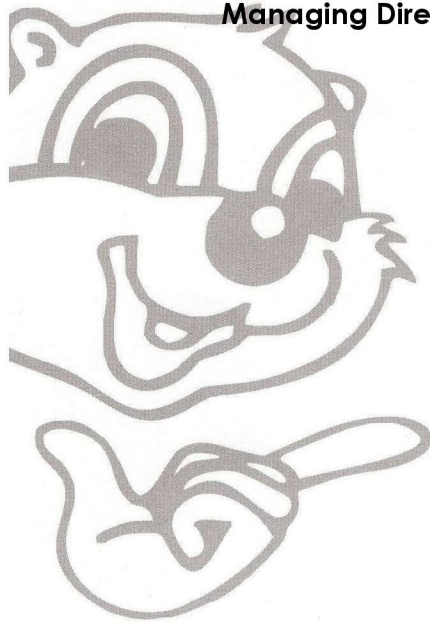
