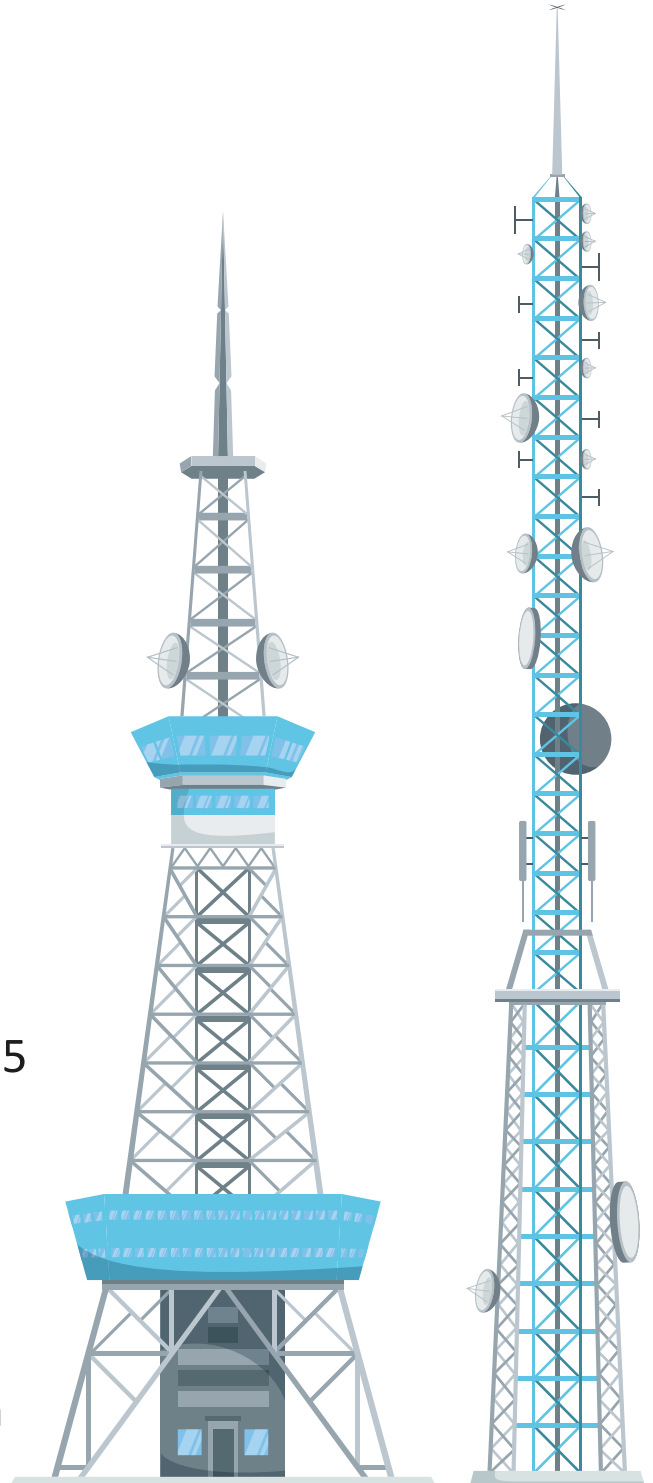

Chairman's Note

The global rollout of 5G networks is a significant undertaking, involving extensive infrastructure upgrades and collaboration between governments, telecom providers, and technology companies. 5G promises to drive innovation across various sectors, including healthcare, transportation, and entertainment.

Modern smartphones, equipped with powerful processors, high-resolution cameras, and advanced

connectivity options have been pivotal to this growth. Serve as multifunctional devices, enabling communication, entertainment, and productivity smartphones have become an integral part of our lives. The proliferation of Internet of Things (IoT) devices has also expanded the scope of telecom services. Ranging from smart home appliances to industrial sensors, reliance on telecom networks for connectivity and data transmission increases by the day.

When Steelman Telecom got into this business, it was the dream of the promoters to see India as one connected entity, without any divide between the rural and urban segments when it comes to communication. It gives us great pleasure to find ourselves contributing to this national achievement.

Our tribal communities are rich in culture and tradition, yet they often face significant barriers to education. Addressing these challenges is not just a moral imperative but a strategic investment in the future. By educating tribal children, we empower them to break the cycle of poverty and contribute meaningfully to society. Education provides these children with the tools to access better job opportunities, improve their quality of life, and become leaders within their communities. It fosters critical thinking, innovation, and resilience, qualities essential for navigating an increasingly complex world.

I congratulate the team for taking up initiatives that focus on providing access to quality education,

including scholarships, school infrastructure, and digital learning resources to the tribal children. Collaboration with local organizations is also a welcome approach, as it ensures that programs are culturally relevant and sustainable. By investing in the education of tribal children, Steelman is investing in a brighter, more inclusive future for all.

I end this note urging all to stay confident that together, through unity, innovation, and dedication, we can build a brighter future for our nation, where every dream and every potential will be realized.

From The Desk of the Managing Director

I am happy to report that your company has closed FY 2023-24 with 43.91% growth in revenue, with a PAT increase of 31.45%.

The industry that your company operates in is at a point of constant inflection. New technologies get introduced, bringing in continuous improvements to the field of telecommunication. We have known this since our inception in the Year 2003 and always stayed ready.

The Year 2023-2024 came with a new dynamic. The largest democracy in the world was getting ready to choose their government at the centre. The economy had also started changing direction and was searching for a greater depth towards a self-sustaining process of growth. India's economic growth for the full 2023/24 fiscal year was revised up to 8.2%, also the highest among large economies globally.

And the business that Steelman Telecom is in, we need to stay constantly ahead of the curve. The swings notwithstanding, the upward trend of business of your company has remained persistently stable. This signifies opening up a huge possibility across the entire spectrum of the industry, in India and internationally. The thought has always been how to leverage the situations to the advantage of Steelman and its shareholders.

I am happy to report that we are well on our way to realigning the organisation towards maintaining this goal.

I am not repeating the performance metrics of your company, which are elaborated in the succeeding sections. But it will perhaps not be out of place in this context to reiterate the basic goal that defines and separates Steelman Telecom from other companies operating in the same space. As we know, service

providers in the telecom industry are heavily dependent on their teams. Your company has put in a special effort to ensure that we work towards the concept of having a double bottom line, viz.,

(a) commitment to benefitting those who work for Steelman Telecom, and

(b) a financial commitment to operating profitability.

I am proud to report that over the years we have developed a team of dedicated and high-skilled technicians, engineers, and support staff who make our journey of growth possible.

We also acknowledge that many of these teams work in environments that are prone to safety hazards, for which your company takes adequate measures to provide safety kits. This year, we went a step further, by starting Family Connect Programs where we organise regular meetings to sensitize the immediate family and dependants on the safety precautions that the workers need to take. We are hopeful that the constant reminders from near and dear ones will help increase the adoption of health and safety best practices.

No report from any responsible organisation should go without a mention of the contributions made to the environment and society. From this perspective, it makes me proud to mention that your company scores high. As you are aware we hold a 53.10% share in our subsidiary, EC Wheels which operates a 100% electric vehicle-powered fleet offering ride-hailing service in Kolkata, under the brand name Snap-E Cabs. Every kilometre run by Snap-E Cabs saves on the opportunity cost of fossil fuel usage and increases the green cover of the city. Not stopping at that EC Wheels has rolled out charging infrastructure across Kolkata for EV Charging and will be adding more such facilities to augment EV Charging facilities for captive and public requirements, thus motivating the adoption of Zero Emission vehicles.

In the course of the year, your company has organised several nature camps with the employees and their families, especially children. The objective of such camps has been to orient participants on the help we get from nature and also plant saplings.

You will also be happy to note that Steelman Telecom has also started contributing to grooming the future generation. With this vision, your company has taken responsibility for the education of several children from the tribal districts of Kandhamal and Koraput in

Odisha. Over the next few years, we plan to expand the geographical coverage and number of children. It is only through education can we expect our future generation hailing from less connected areas climb up the financial and social pyramids.

The plan for 2024-25 is to reach a revenue target of Rs 250 cr with a higher consolidated PAT. We are confident that both our subsidiaries, EC Wheels and Ethiopia-based Steelman Infrastructure Services, will become more self-reliant and contribute positively towards revenue growth and profitability. Looking further into the future, your company is all set to grow steadily at 30-50% Year-on-Year at least for the next 5 years.

As mentioned earlier in my note, for any service company, human capital is the most important. It will be a matter of pride for all of us when we touch our target of employment generation for 10,000 professionals (direct and indirect). I promise to put in most of my effort on this front.

I started by saying that we need to be extra nimble to stay up to speed with the technology advancements. And I assure you that Steelman Telecom will never tire of ensuring this commitment, even as it continues its journey of growth.

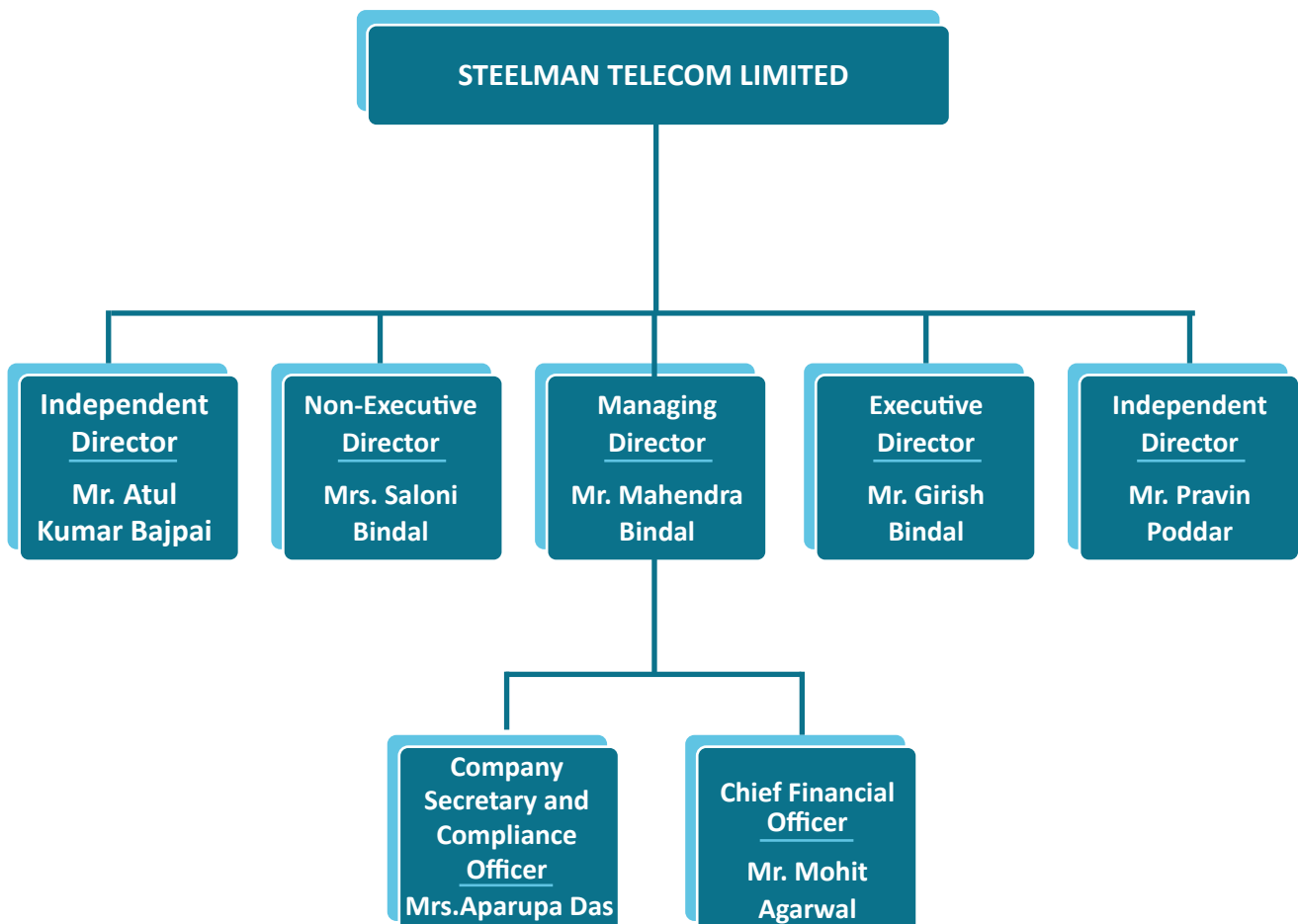

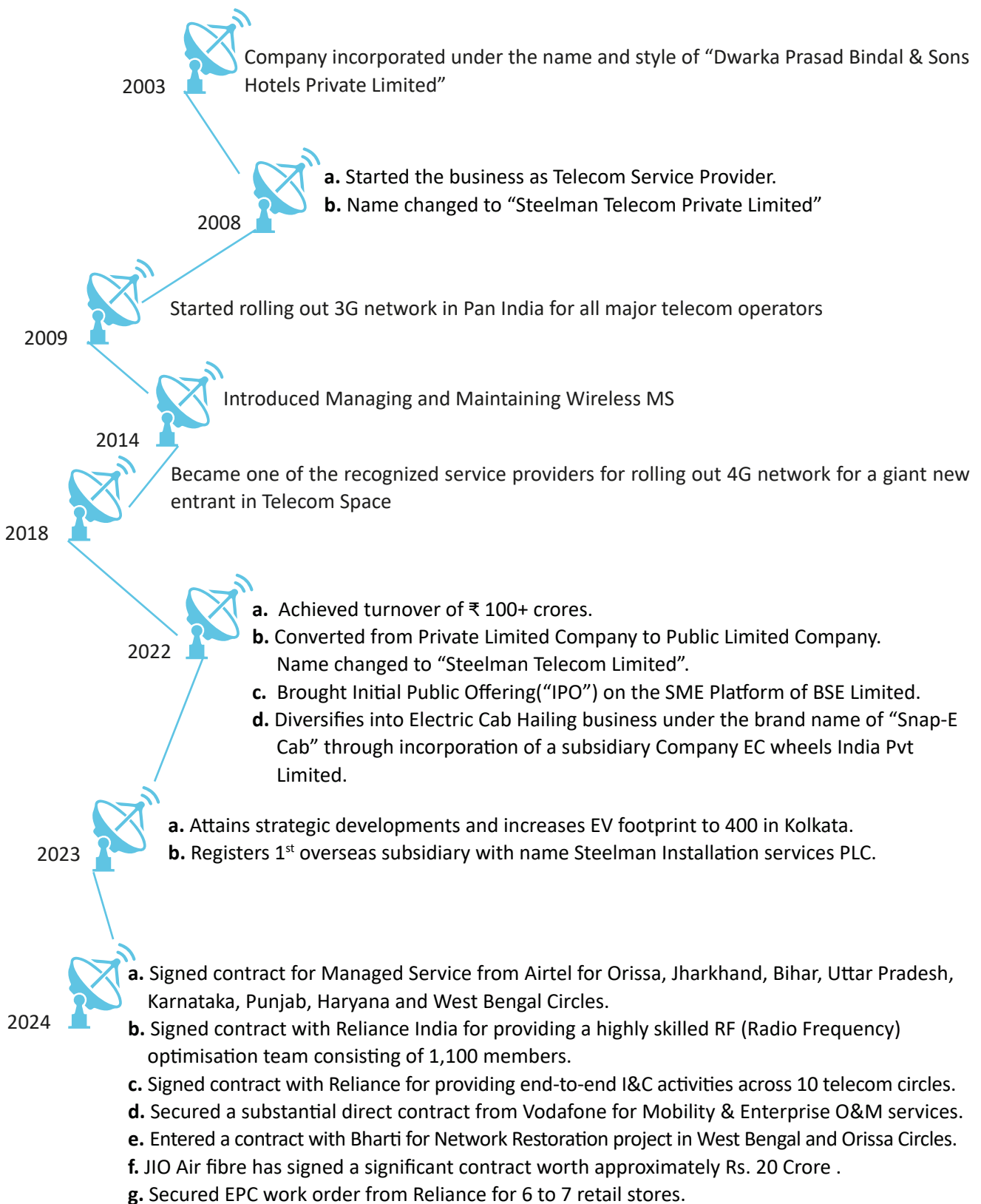
BRIEF HISTORY OF COMPANY

Your Company was originally incorporated on May 12, 2003 as a private limited company in the name of “Dwarka Prasad Bindal & Sons Hotels Private Limited” vide Registration No 96195 under the provisions of the Companies Act, 1956 with the Registrar of Companies, West Bengal. Further, pursuant to a special resolution of our Shareholders passed in the Extra Ordinary General Meeting held on July 23, 2008 name of the Company was changed to “Steelman Telecom Private Limited” and a fresh certificate of incorporation was issued by Registrar of Companies, Kolkata, West Bengal. Subsequently, pursuant to a special resolution of the Shareholders passed in the Extra Ordinary General Meeting held on May 17, 2022 your Company was converted from a private limited company to public limited company and the name of the Company was changed to “Steelman Telecom Limited” and a fresh certificate of incorporation consequent to conversion was issued on July 08, 2022 by the Registrar of Companies, Kolkata, West Bengal being Corporate Identification Number U55101WB2003PLC096195. Your company has approached capital market with its IPO in the month of October, 2022 and got listed on the SME platform of BSE with effect from October, 10, 2022 and the CIN of the Company has been updated with L55101WB2003PLC096195.

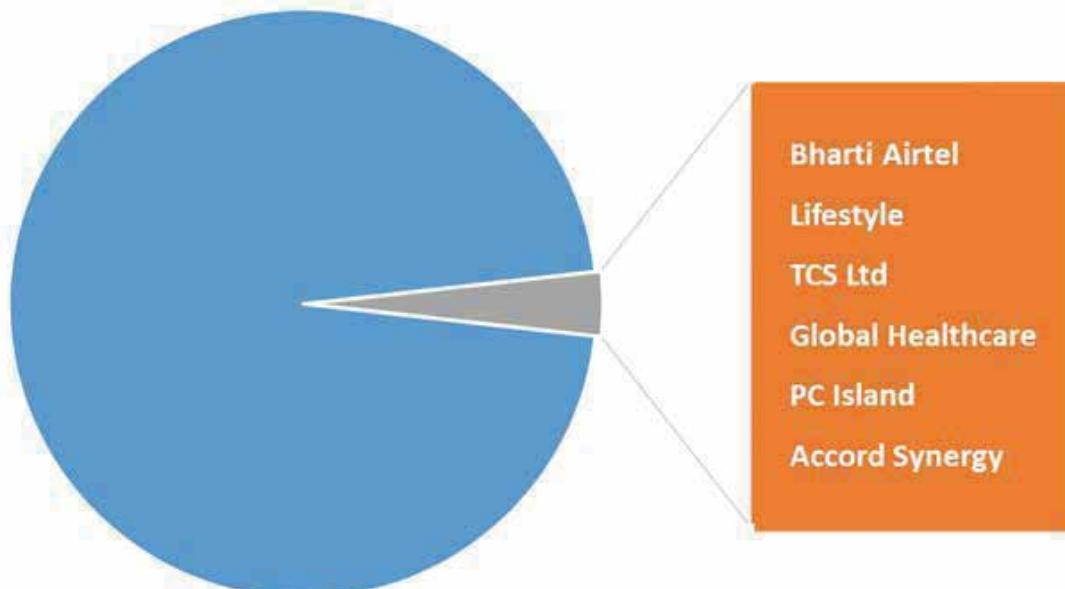

2. FINANCIAL PERFORMANCE

Your Company is primarily engaged in Telecommunication Business and providing highly skilled services to the telecom operators and OEMs. Apart from the services provided in the telecom sectors your Company has decided to carry on business as civil, electrical and mechanical contractors Engineering, procurement, and construction.

Overall, for FY 2023-24, Gross Revenue at Rs. 18939.33 lacs (previous year Rs. 13160.37) grew by 43.91% over previous year, while PAT increased by 31.45% to Rs.732.49 lacs (previous year Rs. 557.21). Earnings Per Share for the year stood at Rs. 7.57 (previous year Rs. 6.43).

However, due to the loss of Rs.1,890.09 lacs, incurred by the Subsidiary Companies M/S EC Wheels India Pvt Ltd and loss of Rs.47.35 Lacs incurred by the foreign Subsidiary Company Steelman Installation Services PLC

(Foreign Entity incorporated in Africa, Ethiopia), the consolidated loss has been increased to Rs. 1204.23 Lacs (previous Year Rs. 82.03 Lacs).

Accordingly consolidated Loss Per Share for the year stood at Rs. 3.29 as against the Earning Per Share of Rs. 0.96 over previous Year.

Your Board is of the opinion that the overall situation would improve with the higher revenue and profit generation by the subsidiaries in the next year.

3. STATE OF THE COMPANY'S AFFAIRS

Your Company having presence PAN India, headquartered in Kolkata having branch offices at Bhubaneswar, Gurgaon, Punjab, Uttar Pradesh and Bihar. Your Company has Project Sites in Telecom Circles across India.

Your Company provide services for Network Survey and Planning, Installation and Commissioning, Network Testing and Optimization, Network Solutions and Managed Services for network maintenance. Strong technical background enables your Company to effectively carry out end-to-end services thereby covering the entire network & technology service solutions. Understanding of critical aspects of a technology and utilizing the same to improve coverage, capacity and quality of today's networks leads to network quality improvement; thereby enhancing every subscriber's experience. Technically skilled field workforce ensures effective planning and execution of the projects. Understanding of new technologies and proven track record of good quality services is complimented with efficient internal processes. Over the years your Company have been successfully implementing various projects and have been recognized by its clients for quality and timely execution of the projects undertaken. This expertise and capability have helped the company to achieve continuous growth and success.

A Special Resolution has been passed at the Extraordinary General Meeting of the Company held on 8th January,2024. Such warrant is convertible into 10,00,000 (Ten Lakhs) Equity Shares (One Equity Share for One Warrant issued) of the Company upon payment of the balance consideration of 75% of the issue price per warrant, i.e. Rs. 128.25 (Rupees One Hundred Twenty-Eight Rupees and Twenty-Five Paisa) each by the allottees on or before the expiry of 18(eighteen)months from the date of allotment of the warrants.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

RECENT INDUSTRIAL SCENARIO

The telecommunication industry is undergoing a significant transformation driven by advancements in technology and evolving market demands. Initially, the focus was on Communication Technology (CT), marking the first wave of the information era. The second phase, beginning around 2000, saw the rise of the internet, realigning the industry around horizontal solutions, e-commerce, and portals. The third phase started post-2006 with the advent of cloud computing. As of 2024, the industry is deeply embedded in the cloud era, with new opportunities continuously emerging for carriers. This era is characterized by the proliferation of 5G, artificial intelligence (AI), and the Internet of Things (IoT), indicating an unstoppable trend.

In the Union Budget 2023-24, the Department of Telecommunications was allocated Rs. 92,000 crore (approximately US\$ 11.35 billion). Revenue expenditure accounted for 38% and capital expenditure for 62%. The Foreign Direct Investment (FDI) inflow in the telecom sector reached US\$ 42 billion from April 2000 to December 2023.

The telecom industry has experienced long-term shifts in market dynamics. Accelerated network traffic growth, new business models, and mature cloud services have reshaped the landscape. The importance of robust networks has never been higher. The Government of India's initiatives, such as setting up one hundred labs for developing applications using 5G services in engineering institutions, aim to harness new opportunities, business models, and employment potentials.

Currently, India is the world's second-largest telecommunications market with a total telephone subscriber base of 1,190.33 million in December 2023 and has registered strong growth in the last decade.

GLOBAL TELECOMMUNICATION MARKET

The global telecom services market was valued at USD 1,925 billion in 2023 and is projected to expand at a compound annual growth rate (CAGR) of 6.4% from 2024 to 2030. The rising investment in 5G infrastructure due to a shift in customer preference towards next-generation technologies and smartphones remains a key growth driver. The surge in mobile subscribers, demand for high-speed data connectivity, and increasing demand for value-added managed services continue to propel market growth. Significant technological advancements in the global communication network have driven improvements in data speeds from GSM and CDMA to 3G, 4G, and now 5G networks. The Asia-Pacific region is expected to maintain the largest market share by 2030, driven by e-commerce growth, smartphone ubiquity, and substantial investments in 5G networks. China, Japan, and India are major contributors to regional growth, with China and India leading in global internet user numbers. The telecommunications industry includes a set of communication instruments. The global growth in demand for communications is pushing the market possibilities for telecommunication. Telecommunication has played an important role in enhancing the quality of communication, particularly through voice and video conferencing. In Global Telecommunication Market size was valued at USD 1700.2 billion in 2019 and is poised to grow from USD 1805.61 billion in 2023 to USD 3102.74 billion by 2031, growing at a CAGR of 6.2% in the forecast period (2024-2031).

FUTURE INDUSTRY SCENARIO

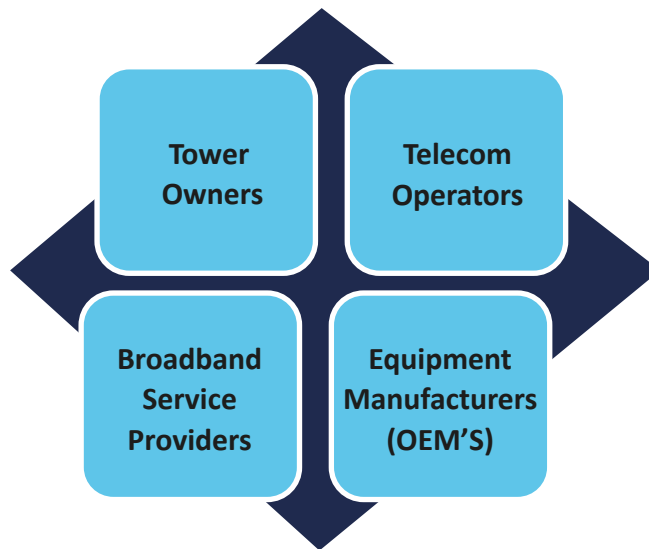
India's digital economy is projected to reach \$1 trillion by 2025, with 5G subscriptions expected to hit 400 million by 2026. The telecommunications industry encompasses several subsectors: Infrastructure, Equipment, Mobile Virtual Network Operators (MVNOs), White Space Spectrum, 5G, Telephone Service Providers, and

Broadband. According to GSMA, India is on track to become the second-largest smartphone market globally by 2025, with around 1 billion installed devices and 950 million unique mobile subscribers, including 120 million 5G connections. The Indian Telecom Tower industry has seen significant growth over the past decade, averaging 31,000 new towers annually. 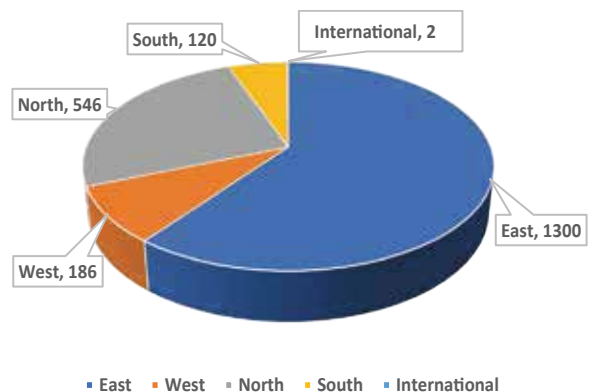

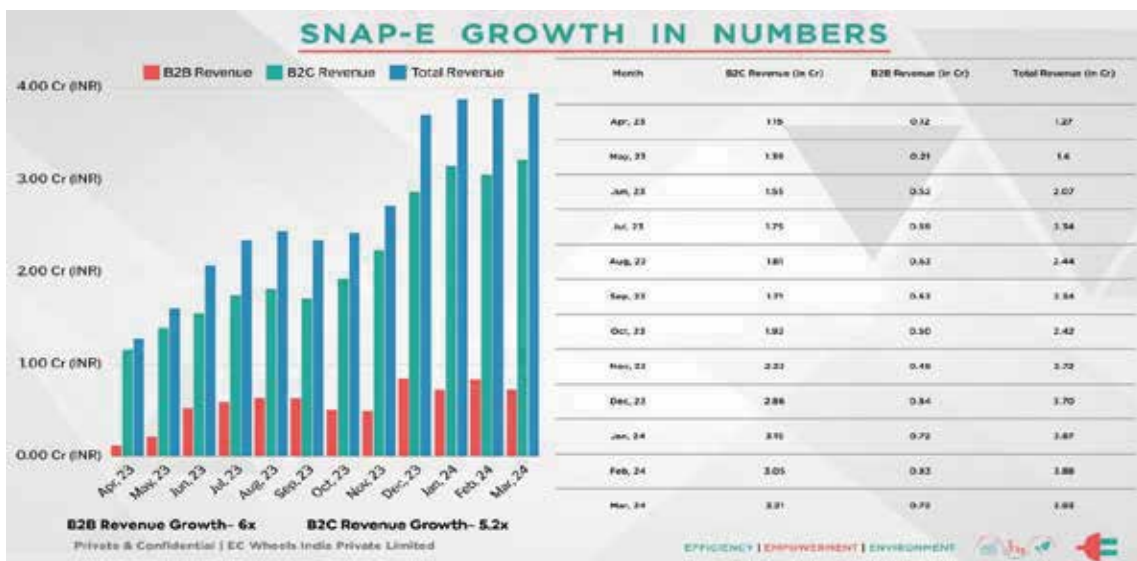

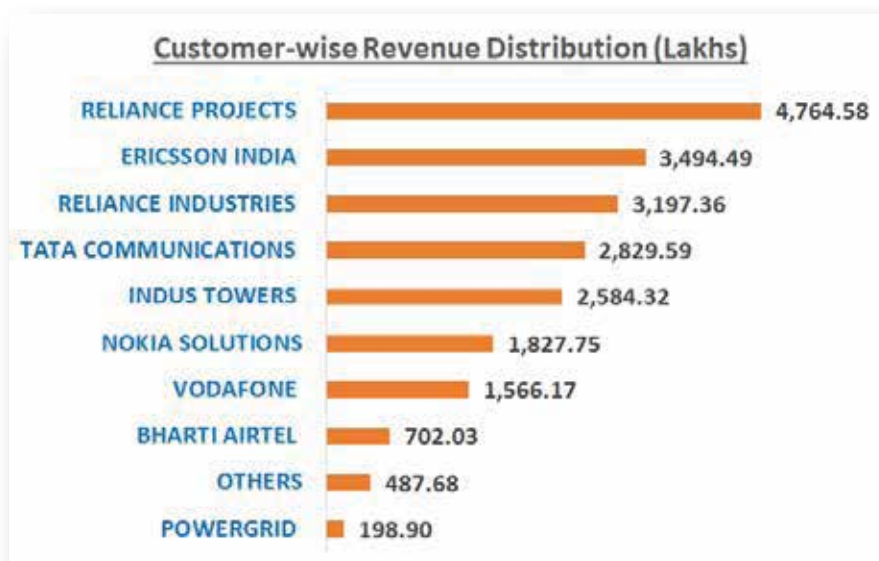


DISCUSSION ON FINANCIAL PERFORMANCE

Your Company is primarily engaged in Telecommunication Business and providing highly skilled services to the telecom operators and OEMs. Apart from the services provided in the telecom sectors your Company has decided to carry on business as civil, electrical and mechanical contractors Engineering, procurement, and construction.

Overall, for FY 2023-24, Gross Revenue at Rs. 18939.33 lacs (previous year Rs. 13160.37) grew by 43.91% over previous year, while PAT increased by 31.45% to Rs.732.49 lacs (previous year Rs. 557.21). Earnings Per Share for the year stood at Rs. 7.57 (previous year Rs. 6.43).

However, due to the loss of Rs.1,890.09 lacs, incurred by the Subsidiary Companies M/S EC Wheels India Pvt Ltd and loss of Rs.47.35 Lacs incurred by the foreign Subsidiary Company Steelman Installation Services PLC (Foreign Entity incorporated in Africa, Ethiopia), the consolidated loss has been increased to Rs. 1204.23 Lacs (Previous Year Rs.82.03 Lacs). Accordingly consolidated Loss Per Share for the year stood at Rs. 3.29 as against the Earning Per Share of Rs.0.96 over the previous Year.

NOTE 1 - SIGNIFICANT ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

- (a) The financial statements are prepared in accordance with Generally Accepted Accounting Principles (Indian GAAP) under the historical cost convention on accrual basis and on principles of going concern. The accounting policies are consistently applied by the Company.
- (b) The financial statements are prepared to comply in all material respects with the Accounting Standards specified under section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014 and provisions of Companies Act, 2013.
- (c) The preparation of the financial statements requires estimates and assumptions to be made that affect the reported amounts of assets and liabilities on the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Differences between the actual results and estimates are recognized in the period in which the results are known / materialize.

1.2 Revenue Recognition

- (a) The company generally follows the mercantile system of accounting and recognizes Income & Expenditure on accrual basis.
- (b) Sales are recognized at the time of passage of the title that generally coincides with their delivery. Sales are net of GST and Trade discounts.
- (c) Machine and labour charges are recognized as per the job invoices raised during the year.
- (d) Interest income is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable.

1.3 Property, Plant & Equipment and Intangible Assets & Depreciation

- (a) Fixed Assets are stated at Cost less accumulated depreciation. The Company has capitalized all cost relating to the acquisition and installation of Fixed Assets.
- (b) Depreciation is provided on Fixed Assets on Written down value Method on the basis of Useful Life as prescribed under Part C of Schedule - II of the Companies Act, 2013.
- (c) Cost of the fixed assets not ready for their intended use at the Balance Sheet date together with all related expenses are shown as Capital Work-in-Progress.
- (d) There are no Intangible Assets in the company.

1.4 Impairment of Assets

The carrying amounts of assets are reviewed at each balance sheet date if there is any indication of impairment based on internal/external factors. An impairment loss is recognized wherever the carrying amount of an asset exceeds its recoverable amount. The recoverable amount is the higher of the asset's net selling price and value in use, which is determined by the present value of the estimated future cash flows.

1.5 Investments

Investments classified as long-term investments are stated at cost. Provision is made to recognize any diminution other than temporary in the value of such investments. Current investments are carried at lower of cost and fair value.

1.6 Inventories

Inventories consisting of Tools & Consumables are valued at lower of cost and net realizable value. Cost of inventories comprises of material cost on FIFO basis and expenses incurred in bringing the inventories to their present location and condition.

1.7 Employee Benefits

Retirement benefit in the form of provident fund is a defined contribution scheme. The contribution to the provident fund is charged to the statement of profit and loss for the year when an employee renders the related services.

During the year gratuity payable to employees are provided based upon actuarial valuation report.

Leave encashment to the employees are accounted for as & when the same is claimed by eligible employees.

1.8 Borrowing Costs

(a) Borrowing costs that are directly attributable to the acquisition of qualifying assets are capitalized for the period until the asset is ready for its intended use. A qualifying asset is an asset that necessarily takes substantial period of time to get ready for its intended use.

(b) Other Borrowing costs are recognized as expense in the period in which they are incurred.

1.9 Taxes on Income

Tax expense comprises of current tax and deferred tax.

Current income tax is measured at the amount expected to be paid to the tax authorities, computed in accordance with the applicable tax rates and tax laws.

Deferred Tax arising on account of "timing differences" and which are capable of reversal in one or more subsequent periods is recognized, using the tax rates and tax laws that are enacted or substantively enacted. Deferred tax asset is recognized only to the extent there is reasonable certainty with respect to reversal of the same in future years as a matter of prudence.

1.10 Earnings per Share (EPS)

(a) Basic earnings per share is calculated by dividing the net profit or loss for the period attributable to equity shareholders by the weighted average number of equity shares outstanding during the period.

(b) For the purpose of calculating diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effects of all dilutive potential equity shares.

NOTE 1 - SIGNIFICANT ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

- (a) The financial statements are prepared in accordance with Generally Accepted Accounting Principles (Indian GAAP) under the historical cost convention on accrual basis and on principles of going concern. The accounting policies are consistently applied by the Company.
- (b) The financial statements are prepared to comply in all material respects with the Accounting Standards specified under section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014 and provisions of Companies Act, 2013.
- (c) The preparation of the financial statements requires estimates and assumptions to be made that affect the reported amounts of assets and liabilities on the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Differences between the actual results and estimates are recognized in the period in which the results are known / materialize.

1.2 Revenue Recognition

- (a) The company generally follows the mercantile system of accounting and recognizes Income & Expenditure on accrual basis.
- (b) Sales are recognized at the time of passage of the title that generally coincides with their delivery. Sales are net of GST and Trade discounts.
- (c) Machine and labour charges are recognized as per the job invoices raised during the year.
- (d) Interest income is recognized on a time proportion basis taking into account the amount outstanding and the rate applicable.

1.3 Property, Plant & Equipment and Intangible Assets & Depreciation

- (a) Fixed Assets are stated at Cost less accumulated depreciation. The Company has capitalized all cost relating to the acquisition and installation of Fixed Assets.
- (b) Depreciation is provided on Fixed Assets on Written down value Method on the basis of Useful Life as prescribed under Part C of Schedule - II of the Companies Act, 2013.
- (c) Cost of the fixed assets not ready for their intended use at the Balance Sheet date together with all related expenses are shown as Capital Work-in-Progress.
- (d) Intangible asset purchased are initially measured at cost. The cost of an intangible assets comprises its purchase price including duties and taxes and any costs directly attributable to making the assets ready for their intended use. The useful lives of intangible assets are assessed as either finite or indefinite. Finite-life intangible assets are amortized on a straight-line basis over the period of their estimated useful lives.

1.4 Impairment of Assets

The carrying amounts of assets are reviewed at each balance sheet date if there is any indication of impairment based on internal/external factors. An impairment loss is recognized wherever the carrying amount of an asset exceeds its recoverable amount. The recoverable amount is the higher of the asset's net selling price and value in use, which is determined by the present value of the estimated future cash flows.

1.5 Investments

Investments classified as long-term investments are stated at cost. Provision is made to recognize any diminution other than temporary in the value of such investments. Current investments are carried at lower of cost and fair value.

1.6 Inventories

Inventories consisting of Tools & Consumables are valued at lower of cost and net realizable value. Cost of inventories comprises of material cost on FIFO basis and expenses incurred in bringing the inventories to their present location and condition.

1.7 Employee Benefits

Retirement benefit in the form of provident fund is a defined contribution scheme. The contribution to the provident fund is charged to the statement of profit and loss for the year when an employee renders the related services.

During the year gratuity payable to employees are provided based upon actuarial valuation report.

Leave encashment to the employees are accounted for as & when the same is claimed by eligible employees.

1.8 Borrowing Costs

- (a) Borrowing costs that are directly attributable to the acquisition of qualifying assets are capitalized for the period until the asset is ready for its intended use. A qualifying asset is an asset that necessarily takes substantial period of time to get ready for its intended use.
- (b) Other Borrowing costs are recognized as expense in the period in which they are incurred.

1.9 Taxes on Income

Tax expense comprises of current tax and deferred tax.

Current income tax is measured at the amount expected to be paid to the tax authorities, computed in accordance with the applicable tax rates and tax laws.

Deferred Tax arising on account of "timing differences" and which are capable of reversal in one or more subsequent periods is recognized, using the tax rates and tax laws that are enacted or substantively enacted. Deferred tax asset is recognized only to the extent there is reasonable certainty with respect to reversal of the same in future years as a matter of prudence.

1.10 Earnings per Share (EPS)

- (a) Basic earnings per share is calculated by dividing the net profit or loss for the period attributable to equity shareholders by the weighted average number of equity shares outstanding during the period.
- (b) For the purpose of calculating diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effects of all dilutive potential equity shares.

1.11 Prior Period Items

Prior Period and Extraordinary items and Changes in Accounting Policies having material impact on the financial affairs of the Company are disclosed in financial statements.

1.12 Provisions / Contingencies

- (a) Provision involving substantial degree of estimation in measurements is recognized when there is a present obligation as a result of past events and it is probable that there will be an outflow of resources.
- (b) Contingent Liabilities are shown by way of notes to the Accounts in respect of obligations where, based on the evidence available, their existence at the Balance Sheet date is considered not probable.
- (c) A Contingent Asset is not recognized in the Accounts.

1.13 Segment Reporting

A. Business Segments:

Based on the guiding principles given in Accounting Standard 17 (AS - 17) on Segment Reporting issued by ICAI, the Company has two reportable Business Segment i.e. contractual maintenance work and business of interior work (EPC). The company has started its interior work (EPC) segment during the F.Y. 2022-23 only and its subsidiary M/s. EC Wheels India Private Limited is engaged into cab hiring business. Accordingly, the figures appearing in these financial statements relate to the Company's these two Business Segment.

B. Geographical Segments:

The Company activities / operations are confined to India and as such there is only one geographical segment. Accordingly, the figures appearing in these financial statements relate to the Company's single geographical segment.
