Accelerating EV Growth: Amara Raja signs Signs MoU with Piaggio India

Collaborates for development and supply of lithium-ion cells, battery packs, and chargers

Hyderabad, 10th August 2024: Amara Raja Advanced Cell Technologies Private Limited (ARACT), a wholly owned subsidiary of Amara Raja Energy & Mobility Limited (ARE&M), one of India's leading battery manufacturers, has signed a Memorandum of Understanding (MoU) with Piaggio Vehicles Private Limited, a 100% Indian subsidiary of the Italian auto giant, Piaggio Group.
