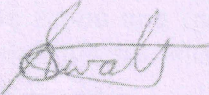

कारगिल युद्धाला २० वर्ष पूर्ण झाल्याच्या निमित्ताने बोलताना वायूसेना प्रमुख बीएस धानोआ यांनी पाकिस्तानला धमकीवजा इशारा दिला आहे. पुन्हा कारगिलसारखे युद्ध झाल्यास आपण कधीही तयार आहोत, असे ते म्हणाले. सर्व चांगल्या जनरल्सप्रमाणे आम्ही अखेरचे युद्ध लढण्यास तयार आहोत, असे म्हणत त्यांनी पाकिस्तानला इशारा दिला. शेजारी पाकिस्तानने काही हालचाल केल्यास त्याचे परिणाम भोगावे लागतील, हे त्यांनी स्पष्ट केले. पाकिस्तानने पाच महिने आपल्या हवाई क्षेत्रात भारतीय विमानांना प्रवेश बंदी केली होती. ही बंदी पाकिस्तानने स्वतःहून मागे घेतल्यानंतर काही तासातच बीएस धानोआ यांचा हा सूचक इशारा आलाय. गरज पडल्यास
