KANCHAN VASDEV CHANDIGARH, NOVEMBER 8 THE SUPREME COURT'S observation on phasing out paddy from Punjab may be easier said than done as the state contributes a large chunk to the central pool and causes significant amount of revenue to the central government, according to a noted economist and a top state government source. On Tuesday, during a hearing on air pollution in Delhi-NCR and stubble burning, the top court had said that the growth of paddy, a crop native to Punjab, is causing the water table to decline. "Paddy cultivation must be phased out to be substituted with other crops and the Central government should explore the aspect of giving a minimum support price for alternative crops," it said.
