This has reference to our intimation dated August 13, 2020 in respect of resignation of Walker Chandiok & Co, LLP, Chartered Accountants (Firm Registration No. - 001076N/N500013), Statutory Auditors of the Company. Please Note that:

The Audit Committee members at their Meeting held today on August 14, 2020 deliberated on the resignation of Walker Chandiok & Co. LLP along with the reasons mentioned therein.

The Committee was of the view that the auditors' remuneration is commensurate and comparable with the business operations and generally being paid by the peers in the Industry. The text of the resolution passed by the Audit Committee for the said matter is as under:
