KCR has no right to criticise Rahul

HANS NEWS SERVICE HYDERABAD

FPCC president T Jagga Reddy strongly objected to BRS chief K Chandrababu Naidu's criticism of Rahul Gandhi. In a media conference on Thursday, Jagga Reddy stated that the Congress party does not fear 'jackals'. He highlighted Rahul Gandhi's extensive 1,000-kilometer padyatra from Kanyakumari to Kashmir, contrasting it with KCR's inability to walk even 10 kilometers.

Addressing the state's financial situation, Jagga Reddy noted that Telangana was a surplus state at its formation but has been pushed into a debt trap under KCR's regime. He mentioned that Chief Minister A. Revanth Reddy and Finance Minister Shanti Vikramarka are trying to restore the state's finances.

Jagga Reddy criticised KCR for supporting the BJP government by passing every bill in Parliament. He questioned why KCR supported the BJP and failed to secure the Information Technology Investment Region (ITIR) project for the benefit of Telangana's youth.

Rahul took up 4000 km padyatra across the country; KCR cannot walk even 10 km; Jagga demands ITIR for Hyderabad; position or not vows to work as per High Commands decision



Reiterating his appeal for the sanctioning of ITIR to Hyderabad, he urged Union Ministers G. Kishan Reddy and Bandi Sanjay Kumar to take special interest and ensure the Centre approves the project. He emphasized that he would continue to remind them until ITIR is granted to Telangana.

Responding to a question about BRS MLC Kavitha's comments, Jagga Reddy expressed empathy for the difficulties she faced during her four-month imprisonment and questioned the necessity of unnecessary political criticisms against the Chief Minister. He advised her to stop calling him 'Pink Book' warning that if Revanth reacts, she would feel bad.

He highlighted his long-standing involvement in state politics, having served as a councillor, municipal chairperson, and MLA of Sangareddy. He emphasized that he remains active in state politics regardless of electoral outcomes.

BIRD FLU

Centre dispatches teams to assess impact in state



MINISTER for agriculture and animal husbandry K. Atchannaaidu said on Thursday that the Central government has dispatched teams to Andhra Pradesh to assess the situation after Avian Influenza broke out in some parts of erstwhile Godavari districts and NTR district.

He said over 5.4 lakh chickens have died due to bird flu known as avian influenza. Addressing the media at the Secretariat in Amaravati, the minister said the poultry farms are culling the affected birds and the department of animal husbandry is creating restricted red zones in the affected areas.

He informed that Badampudi village in Eluru district reported the death of 2.2 lakh chickens, Velupuru in West Godavari district recorded 2.5 lakh deaths, Kamuru Agraharam in East Godavari district reported 65,000 deaths and over 7,000 chickens died in Gampogudem mandal in NTR district. Atchannaaidu said Chief Minister N Chandrababu Naidu had spoken to the senior scientists in Bhopal and the secretary of the Union government and apprised the situation. He said the Central government dispatched teams to Andhra Pradesh and they will visit the bird flu affected areas in erstwhile Godavari districts and NTR. "The animal husbandry department teams are implementing strict measures to check the spread of influenza by forming bio-secure zones and imposing restrictions on movement of vehicles. The culling of chickens has been completed at three affected poultry farms and the rest of the work would be completed in two days," he explained. Atchannaaidu made it clear that people can consume the thoroughly cooked chicken and eggs. He alleged that some sections of media is creating rumours on the avian influenza and stated that people need not panic about the avian influenza known as bird flu.

Director of the animal husbandry department Damodar Naidu said 721 Rapid Response Teams (RRTs) are taking mea-

asures to control the disease. He said transportation of chickens and related products is being closely monitored at state borders and the department remains vigilant, implementing all necessary containment measures. Damodar Naidu informed that one km radius around the wild disease affected area has been declared as an alert zone while a 10 km radius around the affected villages has been declared as surveillance area, restricting the movement of chickens and related products.

Telangana turned from revenue surplus to debt-ridden State: Nirmala Sitharaman

NEW DELHI: Union Finance Minister Nirmala Sitharaman has made some critical comments on Telangana State's economy. She alleged that revenue surplus Telangana State had now been turned into a left-ridden State.

During a debate on the budget in the Rajya Sabha, Nirmala Sitharaman said at the time of bifurcation of AP, Telangana was a surplus budget State but now it had become a debt ridden State while making it clear that she is not blaming any party. "The Modi government had earlier set up a railway station in Medak constituency, where Indira Gandhi won. It was the Modi government that revived the Ramapundam fertilizer factory. We have increased the capacity of fertilizer production to a record 12.7 lakh metric tonnes. The Prime Minister is credited with setting up a turmeric board in Nizamabad. Nizamabad is an amazing turmeric cultivating region. The Central government has decided to set up an industrial corridor in Zaheerabad to provide a scientific hub to Telangana."



We have sanctioned Warangal PM Mitra Kakatiya Mega Textile Park, Sammakura Sarakka Tribal University, AIIMS in Bibinagar to the State," she said.

She also said they were constructing 2,605 km of National Highways, four green corridors under Bharatmala in the State and added that they had allocated a budget allocation of Rs 5337 crore to Telangana for the development of railways.

Botcha demands timelines for implementing welfare schemes

DEMANDING timelines for implementation of welfare schemes as assured by the NDA government, YSRCP senior leader and MLC Botcha Satyanarayana pointed out that people could not even avail the existing schemes despite the coalition government turning nine-month-old.

Speaking to media here on Thursday, the MLC said that people are at a loss as the NDA government failed to meet its promises. "When the opposition leaders point out failures, false cases are being filed against them," Satyanarayana said.

Barring a few, the NDA government failed to meet the promises made, he criticised. Referring to Chief Minister N Chandrababu

About utilisation of Rushikonda project, the MLC said it's the government building and if the state government fails to make use of the building, it shows its inefficiency. Expressing concern that the price of essential commodities has gone beyond common man's reach and

power tariff is hiked, the MLC pointed out that they should give the priorities of the government that are not people's welfare.

He said former chief minister Y S Jagan Mohan Reddy implemented the poll promises with commitment and the state finances were better than national average despite Covid-19 pandemic. He claimed that all sections of people have been badly affected due to lack of proper governance and said non-implementation of Super Six will be taken up in the Council.

Cong MP condemns Nirmala's remarks

HYDERABAD: Congress MP Anil Kumar Yadav has strongly condemned Union Finance Minister Nirmala Sitharaman's recent remarks towards the Telangana State.

In a release here on Thursday, Rajya Sabha MP Anil Kumar Yadav said that Telangana was a revenue surplus State at the time of bifurcation, but due to the misgovernance and financial mismanagement of the former chief minister K Chandrababu Naidu's regime, the State has now fallen into a deficit. "Adding to this injustice, the Union government has failed

to fulfill key promises made to Telangana over the last 10 years. Critical projects like the Bayyaram Steel Plant and various Central Institutions promised during bifurcation remain unfulfilled. These delays have hindered the state's growth and denied the people of Telangana the opportunities they rightfully deserve," he pointed out.

Alleging that Telangana is not receiving its fair share of tax revenue from the Union government, the Congress MP said that despite being a major contributor to the nation's economy,

the State is being deprived of its rightful resources, affecting development projects and essential public services. This imbalance is unacceptable and the people of Telangana will no longer tolerate a state that is being treated this stepmotherly treatment, he said.

Anil Kumar Yadav urged the Union government to correct these injustices, release the funds owed to Telangana and fulfill all pending commitments. "Telangana deserves fair treatment and as a representative of the people, I will continue to fight for the state's rights and development," he added.

Police arrest seven more in Chilukur priest attack case

HYDERABAD: Seven more accused were arrested in connection with the attack case in which the head priest of Chilukur Balaji temple Rangarajan was attacked in the name of Rama taylor army. Motibad police said they had arrested seven persons from vrakulam, East Godavari and Bhadrachalam areas and added that so far, 11 people had been arrested in the case and were remanded to judicial custody. The

police are on the lookout for some others who are absconding.

According to the remand report, Kovvuri Veera Raghava Reddy, founder of Ramarajyam army, haled from Koppavaram in Anaparthi mandal of East Godavari district of Andhra Pradesh. It said the accused claimed himself to be the descendant of Ishvakulu dynasty. "With the aim of establishing Ram Rajya, he established the Kosalendra Trust and started collecting donations. He also recruited up to 30 members in his army under the name of Ram Rajyam Army. He met the administrators and priests of Hindu temples and asked them to support his ideology.
