मुंबईत पावसाचे जोरदार पुराणमण झाले आहे. संपूर्ण अंगरेव मॅगना कोरडा गेल्यावर मुंबईत कसकस पावसाचे जोरदार पुराणमण झाले आहे. आज दुसऱ्या दिवशी देखील सकाळपासून मुंबईत पावसाची प्रवाण बॅरिंग सुरू झाली.

मुंबईस अंधेरे जोषधरी, गोगाव, मालाड, कांदिवली, बोकिवली या उपनगरात पावसाचे जोरदार हजेरी लावली. जोरदार पावसाचे मुंबईतील सखल भागात पाणी साचले होते. हलामुखाऱ्यांनी बरबरेल्या अंदाजानुसार मुंबईत गेले दोन दिवस जोरदार पाऊस कोसळत आहे. पहिले कोलत्या सामानत कमी टाक्या पट्टी मिमांज शाळ्यामुळे मुंबईत म्हातराश्रुच्या

अनेक विल्हाळा मुसक्यात पाऊस कोसळत आहे. म्हातराड, विठ्ठल या भागांना पावसाचा येतो असेट देण्यात आला असून कोकण आणि पश्चिम महाराष्ट्रात देखील जोरदार पाऊस कोसळत आहे. मुंबई उपनगरात इतर शहरांच्या जोरदार पावसाचे उपायगती अनेक सल्लाव भाग या पाण्यासाठी नेण्याचे जाणवता विळाळे असेही पूर्ण आणि पश्चिमाती जोषणारा अंधेरी

सर्वे जलयुक्त झाला. अंधेरी सखते तीन ते चार पूट पाणी भरल्यामुळे अंधेरी सखते वाहलुकीसाठी सध्या वेळ करणायत आला आहे. मुंबईत पावसाचे सल्ले कर्मचारी आले. मुंबईत वाहलुकी पाणी टिकाणी प्रवृत्त रकते असे राहून मुंबईत आणि वाहत चाललेला सखतेत पाण्यास मागील सखत असल्याचे विश्वास पावण्यात मिळाले.

मॅनहोलीची झाकणे चोरीला जात असल्याचे जाळ्यांचा उपाय

मुंबईतील मॅनहोले सुरक्षित करण्यासाठी मुंबई महापालिकेकडून विविध प्रयोग निवडले जात आहेत. पालिकेच्या मलिन-साण विभागकडून नवीन प्रकारातील १०० संरक्षक जाळ्या बसवण्याचा प्रयोग केला जाणार आहे. या जाळ्या बसवण्यासाठी विविध जागा काढावहाई जागे केले आहेत. त्यानुसार नुबिदात आडवड्यापासून जाळ्या बसवण्यास सुरुवात केली जाणार असल्याची माहिती मलिन-साण विभागातील सूत्रांनी दिली. मलिन-साण विभागाने मुंबईत ७४ हजार, चार पंच-वज्रवाहिन्या विभागाचा २५ हजारहून अधिक मॅनहोले आहेत. हे मॅनहोले संरक्षित करण्यासाठी मुंबई महापालिकेकडून प्रयत्न केले जात आहेत. दौड धावत मॅनहोलीचा चोरीला जाणे किंवा ते नसणे, झाकण खराब होणे किंवा तुणेने जाळ्या उतरल्या होणे आहे. मॅनहोलेचे झाकण



चोरीला गेल्यावर वेद-गुहा दाखल करण्याचे आदेश मुदरम्यांनी दिले आहेत. तसेच नुकल्याच झालेल्या नुबानागत उधेडे मॅनहोलेसंदर्भात मुंबई उच्च न्यायालयात नवीन जाणविलेला खडे बोल सुनावले. त्यानंतर मुंबई महापालिकेने मॅनहोले झाकणीची खबरदारी घेण्यास सुरुवात केली आहे. मॅनहोलेत मजबूत संरक्षक जाळ्या

बसवण्यास उच्च न्यायालयानेही पालिकेला सूचना केली असून कुटी आराखडा तयार करण्यासाठी मुंबई नुबानागत जायरी सांगणे आहे. त्यानुसार मुंबई महापालिकेच्या मलिन-साण विभागाने देवलेले स्टील, फायबर आणि इतडाइल जाळ्या बसवण्याचे नियोजन केले आहे. प्रती प्रकारातील १०० जाळ्या पूट उपनगर, पश्चिम उपनगर आणि शहर भागातील मलिन-साणच्या अखत्यारीतील मॅनहोलेवर बसवण्यात येणार आहेत. या १०० जाळ्यांसाठी निविदा काढून या बसवण्यासाठी कांदादेही जागी केल्याची माहिती सूत्रांनी दिली. पुढील आडवड्यापासून जाळ्या बसवण्यास सुरुवात केली जाईल. हे काम साधारण दोन आडवड्यात पूर्ण केले जाणार आहे. नवीन प्रकारातील १०० जाळ्यांचा आढावा घेतल्यानंतर मुंबईत मॅनहोलेवर जाळ्या बसवण्यात येणार आहेत. मुंबईतील एकाच मॅनहोलेची साधारण साडेसात हजार मॅनहोलेवर साधारण प्रकारातील जाळ्या बसवण्यात आल्या आहेत.
