## **PRESS RELEASE**

Company has recorded Rs.119.53 cr of sales and a profit before tax of Rs.12.14cr for the quarter ended 30/06/2021 as compared to Rs.96.75 cr of sales and loss of Rs.1.52 cr for the corresponding quarter of previous year. The sales mix is slightly skewed in favor of domestic sales which explains improved profit for the period. Company is expects to do Rs.180 cr worth of sales for second quarter with an even mix of domestic and exports sales.

Company booked around Rs.42 cr worth of order during the quarter and order book stands at around Rs.1,472 cr at the end of the quarter. Expected to book around Rs.400 cr orders before end of second quarter as the Company has successfully completed purchase negotiations with customers and is awaiting release of purchase orders for some major works.

The Company expects to book further orders to the tune of around Rs.300 cr during and carry an order book of close to Rs.1,500 cr into next financial year. The Company is confident to reach Rs.700 cr sales for the year.

Company is taking adequate steps to take advantage of recent Government decisions to encourage domestic defence industry in supply of critical defence supplies for armed forces.

COVID-19 impact on operations of Company is under control and expects to sail through without major hurdles.
