2. During the current period, the Group identified certain errors in respect of earlier period/year pertaining to incorrect accounting of (i) deferred tax liability in respect of business combinations and the corresponding effect on intangible assets/goodwill (ii) performance incentive for the year ended March 31, 2022 and (iii) right of use asset under Ind AS 116 by an overseas subsidiary. This resulted in overstatement / (understatement) of certain line items in the consolidated statement of profit and loss and consolidated balance sheet for the comparative periods as below.

In accordance with Ind AS 8 - "Accounting Policies, Changes in Accounting Estimates and Errors" the Group has corrected the above by restating each of the line items as applicable in the comparative financial information for the quarter and six months period ended September 30, 2021 and for the year ended March 31, 2022. Auditors have included an Emphasis of matter paragraph in this regard in their review report for the current period.

3. On November 30, 2021, the Group acquired "InfoBeans Cloudech Private Limited" (erstwhile Eternus Solutions Private Limited), mainly engaged in supply of IT services under Salesforce platform. The Group allocated the purchase consideration of Rs. 15,953.02 Lakhs to the assets and liabilities (including intangible assets viz. Customer Relationships and Salesforce Platform and Technology Platforms which were not recognized in acquirer's books) based on their acquisition date fair values. The consideration in excess of fair values of the assets and liabilities acquired has been allocated to Goodwill.

4. The Group operates in one segment i.e. Information Technology services. Accordingly, no separate segment disclosures as required under "Ind AS-108: Operating Segments" has been presented.

5. The Code on Social Security, 2020 ("Code") relating to employee benefits during employment and post-employment benefits received Presidential assent in September 2020. The Code has been published in the Gazette of India. However, the date on which the Code will come into effect has not been notified and the final rules/interpretation have not yet been issued. The Company will assess the impact of the Code when it comes into effect and will record any related impact in the period the Code becomes effective.

6. The comparative Ind AS financial information of the Group for the corresponding quarter and six months period ended September 30, 2021 and year ended March 31, 2022, included in these consolidated Ind AS financial results, were audited by predecessor auditor who expressed unmodified opinion on that financial information vide their report issued on October 28, 2021 and April 27, 2022 respectively.

7. Previous period figures have been regrouped / reclassified wherever necessary to conform to current periods classification.

Notes:

1. The Unaudited Consolidated Financial Results have been reviewed and recommended by the Audit Committee and approved by the Board of Directors at their respective Meetings held on 4th November, 2022. In compliance with the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), a limited review of the above results has been carried out by the statutory auditors of the Company.

2. The Unaudited Consolidated Financial Results have been prepared and published in accordance with the Indian Accounting Standards, Section 133 of the Companies Act, 2013 read with Rules framed thereunder and Regulation 33 of SEBI Listing Regulations, as amended from time to time.

3. During the quarter ended 30th September, 2022 the Company has allotted 20,275 equity shares of Rs. 10/- each fully paid-up, on exercise of Restricted Stock Units (RSUs) by eligible employees under the Mahindra Logistics Employee Restricted Stock Unit Plan 2018.

4. The Board of Directors had recommended final dividend of Rs 2/- per equity share for the year ended 31st March, 2022 at its meeting held on 26th April, 2022 which has been approved by the Shareholders at the 15th Annual General Meeting held on 29th July, 2022. The aforesaid dividend was paid during the quarter ended 30th September, 2022 that resulted in a cash outflow of Rs. 14.39 crores.

5. The Company has incorporated a new wholly-owned subsidiary - V-Link Freight Services Private Limited with effect from 9th September, 2022.

6. On 26th September, 2022, pursuant to approval granted by the Investment Committee of the Board of Directors, the Company entered into a Business Transfer Agreement with Rivo Services Private Limited and its promoter for acquisition/purchase of its B2B express business, as a going concern, on slump sale basis, for a lump sum consideration of Rs. 225 crores, by the company or its affiliate, on the terms and conditions more specifically defined in the said agreement. The transaction will be given effect after completion of conditions precedent.

7. Financial information in respect of previous periods viz. Ola e-scooter production at 100,000 units, misses earlier target

Bengaluru, November 4

OLA ELECTRIC HAS completed producing 100,000 million units so far in November since its inception, chief executive officer and founder Bhavish Aggarwal said in a Twitter post on Friday.

"Crossed 1 lakh vehicles produced yesterday. In just 10th month of production, probably fastest ever for a new auto company in India. Just getting started and #EndICEAge is coming nearer and nearer!" he tweeted.

The company, however, missed its target to fully utilise the installed production capacity target it set earlier and achieved only 50%. Company officials had earlier said Ola Electric has a current capacity of 2 million units per annum at its factory and it would be exhausted in the next 6-8 months. However, in a post on Twitter on Friday sharing the company's production targets, Aggarwal wrote, "Our cumulative production numbers: Dec 2021: 0; Nov 2022: 1,00,000; Nov 2023: 10,00,000; Nov 2024: 1,00,00,000...This is the journey to #EndICEAge by 2025."

The company says its mission is to completely end the usage of internal combustion engine (ICE) vehicles by 2025. In pursuit of that goal, the company currently sells two models: the Ola S1 Pro and the Ola S1 electric scooters. It has also announced the launch of Ola S1 Air — to directly compete with the 110 cubic capacity (CC) ICE scooters like Honda's Activa, TVS' Jupiter and Suzuki's Access, among others, by pricing the vehicle at around ₹80,000. The purchase window for the Ola S1 Air opens in February and deliveries will begin in April.
