**Grant of Stock Options under the Employee Stock Option Scheme of the Bank (ESOP Scheme)**

In compliance with Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements), Regulations, 2015, we hereby inform that the Compensation and Nomination & Remuneration Committee on May 12, 2023, had approved grant of 50,661 Stock Options (convertible into 50,661 Equity shares of the Bank, upon exercise) to 1 Eligible Employee in terms of the ESOP Scheme.

The main terms of the grant are mentioned below:

1. **Grant Price:** Rs. 1,187.45 per share (Close Price on NSE on Thursday, May 11, 2023, viz., previous trading day's Close Price at the Stock Exchange having the highest trading volume).
2. **Vesting Period:** 3 years from date of grant, spread at 33%, 33% and 34% at the intervals of one year from the date of grant.
3. **Exercise Period:** 5 years from date of vesting.

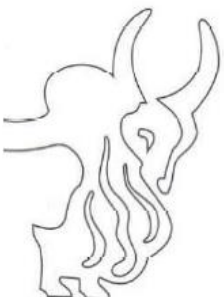
