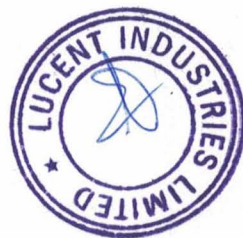

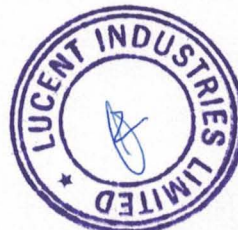

## Opinion


