- The Company has signed a binding term sheet on December 1, 2023 with Ginni Filaments Limited (“**GFL**”) for proposed acquisition of its Spinning, Knitting and Processing Undertaking situated at 110 KM Stone, Delhi-Mathura Road, Chhata, Kosi, Distt. Mathura (UP) – 281401 as a going concern on a slump sale basis for a lump sum consideration of Rs.160 crores, subject to the necessary adjustments as may be specified in the Business Transfer Agreement to be executed in this regard.
- GFL is a company engaged in the business of textiles which, *inter-alia* includes spinning, knitting and processing of textile products, since 1989 in India.

- g) The proposed transaction is expected to be completed within 90 days of the execution of the binding term sheet, subject to completion of conditions precedent and other closing conditions as may be specified in the Business Transfer Agreement to be executed between the Company and RSWM Limited.
- h) With this proposed acquisition, the Company would be in a position to enhance its production capacity and may augment future business prospects of the Company in its textile business.
