तपन दत्ता की हत्या की जांच सीबीआइ को सौंपने के आदेश को चुनौती

जससना व्यूह नई दिल्ली, 1 जुलाई।

परिम वंगल सरकार ने कलकत्ता हाईकोर्ट के आदेश को चुनौती देते हुए चुनौती दी है। न्यायमूर्ति सुब्रह्मण्यन और न्यायमूर्ति जेपी पारीवाल की अक्रमागत पीठ के समक्ष सार्वजनिक और सूचनाओं को उकसे कलौट ने अपील का उल्लेख किया। उन्होंने कहा कि हाईकोर्ट ने यहिकता का निराकरण देना साबित करते हुए जांच सीबीआइ को स्थानांतरित करने का आदेश दे दिया। मामले में लोक अभियोजक को भी बदल दिया गया। ताकतिलिखता का हवाला देते हुए पीठ के कलौट ने पीठ से मामले को तत्काल सुपीनद करने की प्रार्थना की। इस पर पीठ ने सहमत जवाब देकर कहा कि मामले की सुनवाई आगे ले जाते हुए जांच जारी रखेंगे।

वंगल ने केन्द्रीय जांच ब्यूरो को स्थानांतरित करने का आदेश दिया है। तबसे ही वंगल कोयरी की वल्लेजी जांचा समिति हाईकोर्ट के तत्कालीन उपाध्यक्ष दत्ता की 6 मई, 2021 को मृत्यु के तबसे ही कर रहा कर दी गई थी। दत्ता का वकील 750 कड़ की आदेशों को अपने से केनेने के लिए आदेश का न्यूचर कर रही थी, जब दत्ता की हत्या हुई। इस सरकार ने इस हत्या के मामले में सीबीआइ जांच का आदेश दिया था। लेकिन दत्ता की वल्लेजी प्रमाण दत्ता ने मामले की सीबीआइ जांच की मांग करते हुए हाईकोर्ट का रुख किया। प्रतीति दत्ता ने आपीक लागा कि खाद्य प्रसंकरण मंत्री आरय रय केवले पति की हत्या की जांच में शामिल है। हाईकोर्ट ने कहा कि रय पुलिस पर कुछ लोटे और उनके नामक कारों को चाने के लिए दबाव से डरकाने नहीं किया जा सकता। पीठ पर दत्ता और आम जनता में विचार्य जमाने के लिए परामर्श मामले में जांच और अभियान प्रवृत्ती को बदलना भी आवश्यक है।

कोरोना के 17,070 मामले, 23 और मरीजों की मौत

जससना व्यूह नई दिल्ली, 1 जुलाई।

देश में कोरोना विषुय संक्रमण के 17,070 मामले आने के बाद रोजमिती की कुल संख्या 4,34,69,234 हो गई है। वहीं, संक्रमण का इलाज करा रहे मरीजों की संख्या बढ़ कर 1,07,189 हो गई, जो संक्रमण के कुल मामलों का 0.25 फीसद है।

केन्द्रीय स्वास्थ्य मंत्रालय के शुक्रवार सुबह आने वाले तबसे आंकड़ों के अनुसार 23 मरीजों के जान जाने से मृत्यु की संख्या 5,25,139 पर पहुंच गई है। कोरोना के मरीजों के संख्या होने की राशि 98.55 फीसद है। संक्रमण की रोकथाम के लिए 3.44 फीसद और स्यालिक संक्रमण दर 3.59 फीसद दर्ज की गई। इस बीमारी से स्वस्थ होने वाले लोगों की संख्या बढ़ कर 4,28,36,906 हो गई है।

अक्टूबर से और सुरक्षित होगा यात्रियों का सफर
