US court stays 26/11 attack accused Rana's extradition

WASHINGTON, AUGUST 22

OVERRIDING THE Biden administration's appeal, a US court has ordered a stay on the extradition of Pakistani-origin Canadian businessman Tahawwur Rana to India, where he is facing a trial for his involvement in the 2008 Mumbai terror attacks.

Rana, 62, has appealed before the Ninth Circuit Court against the order by a US District Court in the Central District of California that denied the writ of

habeas corpus. District Judge Dale S Fischer of the US District Court in Central California in his latest order said that Rana's "ex parte application" seeking a stay on his extradition is granted.

"The extradition of Rana to India is stayed pending the conclusion of his appeal before the United States Court of Appeals for the Ninth Circuit," Judge Fischer said in the order issued on August 18.

In doing so, the judge overrode the government's recommendations that there should be no stay on Rana's extradition.

Rana faces charges for his role in the Mumbai attacks and is known to be associated with Pakistani-American terrorist David Coleman Headley, one of the main conspirators of the 26/11 Mumbai attacks

While the court does not find that Rana "has made a strong showing that he is likely to succeed on the merits" -- otherwise it would have ruled in his favour in the first instance – he has certainly raised serious legal questions going to the merits, the

judge wrote. "The proper meaning of 'offence' in Article 6(1) of the extradition treaty is not clear and different jurists could come to different conclusions. Rana's position is certainly colourable and could very well be found to be correct on appeal," the judge

"The final two factors 'merge when the government is the opposing party'. There is value in compliance with India's extradition request, but Rana's extradition proceedings have been going on for more than three years, which suggests that the process has not been rushed so far.



Otherwise, the public interest, if anything, favours Rana," the judge wrote. "The public has a strong in-

terest in the proper interpretation of extradition treaties, particularly in the interpretation of provisions that provide important individual protections like the one at issue here. Further, there is a strong public interest in definitive, binding interpretations of treaties. District courts cannot provide those rulings; courts of appeals can," the judge wrote, throwing the legal battle to the Ninth Circuit Court now.

The US Court of Appeals for the Ninth Circuit has asked Rana to submit his argument before October 10 and the US government has been asked to submit its response by November 8.

Judge Fischer wrote that Rana has shown that he is likely to suffer significant irreparable harm absent a stay.

He will be extradited to India for a trial on serious crimes with no hope for a review of his arguments or hope for his return to the US. The government admits this, but then argues that because "this claimed irreparable harm applies categorically to any fugitive who seeks a stay of extradition pending appeal," it does not count, the judge said.

Earlier the US attorney, John J Lulejian, appealed before the District Court to deny Rana's ex parte application for a stay of extradition pending appeal and argued that the stay would cause "unwarranted delay" in the US's fulfilment of its obligations to India and this will damage its credibility in the international arena and impair its ability to obtain the cooperation of foreign nations in bringing US fugitives

Rana, he argued, cannot show a likelihood of success on the merits of his claims or otherwise meet his burden of justifying a stay. "Accordingly, the US respectfully requests that the Court deny his ex parte application," the US attorney wrote. PTI

अदालत अंकित, सौरभ शर्मा, रोहित, राहल कमार और सचिन के खिलाफ एक मामले की सुनवाई कर रही थी। इन पाँचों आरोपियों पर उस दंगाई भीड़ में शामिल रहने का आरोप है जिसने 25 फरवरी, 2020 को करावल नगर में चोरी करने के अलावा एक धर्मस्थल एवं अन्य संपत्तियों में आग लगा दी थी। अतिरिक्त सत्र न्यायाधीश पुलस्त्य प्रमाचला ने सोमवार को जारी अपने आदेश में कहा कि मैं समझता हूं कि आरोपी व्यक्तियों के विरुद्ध प्रथम दृष्ट्या मामला बनता है।

पीड़िता से मिलने के लिए मालीवाल ने गृहमंत्री को लिखा पत्र

मालीवाल ने कहा कि पुलिस और अस्पताल के अधिकारियों ने उन्हें पीड़िता और उसकी मां से मिलने से रोका जबकि राष्ट्रीय बाल अधिकार संरक्षण आयोग (एनसीपीसीआर) के अध्यक्ष को पीड़िता की मां से बातचीत करने दिया। पत्र में मालीवाल ने कहा कि यह बहुत ही दुर्भाग्यपूर्ण है कि 24 घंटे तक अस्पताल के बाहर इंतजार करने और यहां तक वहीं सोने के बावजूद दिल्ली पुलिस और अस्पताल के अधिकारियों ने मुझे पीड़िता या उसके परिवार से मिलने की अनुमति नहीं दी। बार-बार अनुरोध करने के बावजूद मुझे पीड़िता और उसके परिवार से मिलने नहीं दिया गया। यह दिल्ली पुलिस और निजी अस्पताल द्वारा किया गया गैरकानूनी कृत्य है।

मालीवाल ने शाह से कहा कि वह यह पता लगाने के लिए जांच का आदेश दें कि दिल्ली पुलिस ने आरोपी को गिरफ्तार करने में देरी क्यों की। उन्होंने पीड़िता को बेहतर इलाज के लिए तुरंत एम्स स्थानांतरित करने की भी मांग की। डीसीडब्ल्यू अध्यक्ष ने कहा कि अगर पीड़िता या उसका परिवार इलाज के लिए एम्स नहीं जाना चाहते, तो उस परिस्थिति में एम्स के डाक्टरों की टीम द्वारा पीड़िता की जांच की जानी चाहिए और इलाज की देखरेख करनी चाहिए।
