SUBJECT: SCRUTINIZER'S REPORT ON REMOTE E-VOTING CONDUCTED THROUGH POSTAL BALLOT.

I, Bhupesh Gupta of B.K. Gupta & Associates, Practicing Company Secretaries at SCF-47, Near Abiss, Rishi Nagar Market, Ludhiana was appointed as Scrutinizer by the Board of Directors of MRS.BECTORS FOOD SPECIALITIES LIMITED ("Company") for the purpose of scrutinizing the remote e-voting process in respect of 'Special Resolution' mentioned in the Notice of Postal Ballot dated 10th February, 2023 in a fair and transparent manner pursuant to Section 108, 110 and other applicable provisions, if any, of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (as amended) ("the Rules") and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and circulars issued by the Securities and Exchange Board of India (SEBI) and in compliance with the framework issued by the Ministry of Corporate Affairs (MCA) through its circulars including General Circular No. 11/2022 dated 28.12.2022, Circular No. 03/2022 dated 05.05.2022 read with Circular No 14/2020 dated 08.04.2020 on the below resolution contained in the Notice of Postal Ballot.

1. Special Resolution - To Appoint Mr. Ashish Agarwal (DIN: 00775296) as a Non-Executive Independent Director of the Company.

The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and the Rules made thereunder including MCA Circulars and Listing Regulations relating to the postal ballot by voting through remote e-voting for the resolution contained in the notice of the postal ballot dated 10.02.2023.

My responsibility as a Scrutinizer is to ensure that postal ballot by voting through remote e-voting is carried out in a fair and transparent manner and to provide Scrutinizer's Report on the votes cast "IN FAVOUR" OR "AGAINST" and invalid votes, if any, on the resolution contained in the Notice of Postal Ballot dated 10.02.2023.

Accordingly, I submit my report as under

- 1. Physical copies of the Postal Ballot Notice, postal ballot forms and pre-paid business reply envelopes were not sent to the Members for this Postal Ballot as same were not required to be sent as per the Circulars issued by MCA.
- 2. The Company had engaged the services of Link Intime India Private Limited (LINK INTIME) to provide remote e-voting facility for all its members to cast their votes electronically.
- 3. The Public Advertisement with respect to dispatch of the notices of postal ballot through electronically and conducting of voting through electronic means was published in an English Newspaper "Financial Express" of wide circulation on 25.02.2023 and a Vernacular Newspaper "Desh Sewak" on 25.02.2023.
- 4. For the purpose of this postal ballot, period of e-voting was set out in the notice. The remote e-voting period commenced on Wednesday 01.03.2023 at 09:00 a.m. and ended on Thursday 30.03.2023 at 05:00 p.m.
- 5. Members holding shares as on Friday 17.02.2023, (cut-off date), were entitled to vote on the resolution stated in the notice of the postal ballot. The detailed manner of voting has been explained in the instructions given in the notice of the postal ballot.

- 6. After the conclusion of the voting at 05:00 p.m. Thursday, 30th March, 2023, the votes cast there at were downloaded from the website of LINK INTIME. Thereafter, the votes on remote e-voting were unblocked on Thursday, 30.03.2023 after 5:00 p.m., in the presence of two witnesses who were not employees of the Company and the e-voting results/list of members who have voted for and against were downloaded from the e-voting website of LINK INTIME.
- 7. Particulars of all the postal ballot votes cast through electronic means as recorded through an online platform 09:00 a.m. Wednesday, 01.03.2023 to 05:00 p.m. Thursday, 30.03.2023 have been considered for scrutiny in this report.
- 8. The details of the remote e-voting and the analysis of the results of the Special Resolution as contained in the said Notice and results of Postal Ballot are given as under:
