Dear Sir,

I, Narottam Bagaria, Partner, M/s. N. Bagaria & Associates, Company Secretaries, Mumbai, have been appointed by the Board of Directors of Elegant Floriculture & Agrotech (India) Limited ("the Company") as Scrutinizer for the purpose of scrutinizing the process of voting through electronic means (e-voting) for Postal Ballot and ascertaining the requisite majority on the voting carried out on the resolution contained in the Postal Ballot Notice dated 29th December, 2020, as per the provisions of Sections 108 and 110 of the Companies Act, 2013, read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and the provisions of Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In compliance with provisions of Sections 108 and 110 and other applicable provisions, if any, of the Companies Act, 2013 ("the Act) read with rules made thereunder, Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") and in accordance with the provisions of the General Circular No. 14/2020 dated 8th April, 2020, No. 17/2020 dated 13th April, 2020 and No. 33/2020 dated 28th September, 2020 issued by Ministry of Corporate Affairs, Government of India ("MCA Circulars"), the Company had provided facility for voting through electronic means (e-voting) to all the members of the Company, to enable them to cast their votes electronically instead of submitting the Postal Ballot Form.

The Company had engaged the services of National Securities Depository Limited ("NSDL") to provide e-voting facilities and for security and enabling the members to cast their vote in a secure manner.

The management of the company is responsible to ensure the compliance with the requirements of the relevant provisions of the Companies Act, 2013 and the Rules made thereunder and the applicable regulations of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements), Regulations, 2015, relating to voting by electronic means (e-voting).

My responsibility as Scrutinizer for the e-voting is to ensure that the voting process is conducted in a fair and transparent manner and render Scrutinizer's Report of total votes cast in favour or against by the members on the resolution contained in the notice based on report generated from the electronic platform provided by National Securities Depository Limited (NSDL), the authorized agency to provide e-voting facilities, engaged by the Company

I submit my report as under:

- The Postal Ballot Notice was sent through e-mail on Wednesday, 30th December, 2020 to the members of the Company whose names appeared on the Register of Members as on Friday, 25th December, 2020 and whose e-mail ids was registered with the Company/ Registrar and Transfer Agents/ Depository Participants, in accordance with Section 110 of Companies Act, 2013 read with MCA Circulars;
- 2. On account of the threat posed by the pandemic situation of COVID-19, the Postal Ballot Notice was sent through electronic mode only. The hard copy of the Postal Ballot Notice along with Postal Ballot forms and pre-paid business envelope were not sent to members for the Postal Ballot in accordance with the requirements specified under MCA Circulars. Accordingly, the communication of the assent or dissent of the members took place through the remote e-voting system only.
- The e-voting period commenced from Thursday, December 31, 2020 at 9.00 a.m. IST and ended on Friday, January 29, 2021 at 5.00 p.m. IST;
- The members holding shares as on the cut-off date (record date) of Friday, 25th December, 2020 were entitled to vote on the proposed resolution.
- All electronic votes received up to 5.00 p.m. IST on Friday, 29th January, 2021 being the last date and time fixed by the Company for receipt of electronic votes, were considered for my scrutiny;
- The e-voting results with details of equity shareholders who have voted in favour of resolution or against the resolution and those who have abstained from voting were downloaded from the website of National Securities Depository Limited (NSDL) i.e. (www.evoting.nsdl.com);

- A register containing the details of assent or dissent, received, mentioning the
 particulars of name, address, folio number/ client ID of the shareholders, the
 number of shares held by them, the nominal value of shares held etc. is
 maintained in electronic form;
