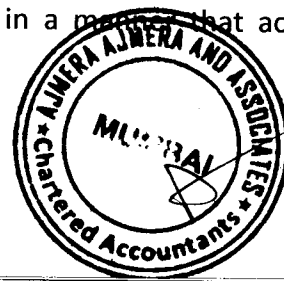


Other Matter

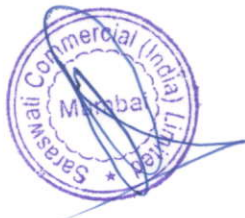

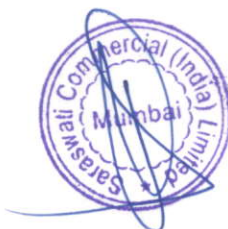


