Financials:

TPL posted revenue of ₹ 513.94 crore compared to ₹ 452.19 crore in corresponding quarter of the previous year. PBT reduced by 24% vis-à-vis Q2FY23. The operating performance reflects stable demand, efficient cost management and reduced realizations in the context of higher energy and input costs.

Our priority has been to fulfill all customer requirements and ensure smooth operation of our manufacturing plants. We look forward to improving the performance in the future.”
