Lookout notice issued against key accused in IELTS scam

AHMEDABAD, SEPTEMBER 15

MEHSANA POLICE on Thursday issued a lookout notice for one of the main accused in the IELTS case, Amit Chaudhary, even as a Special Investigation Team (SIT) has been appointed to investigate the case.

"It is not confirmed whether he (Amit Chaudhary) is in the country or has he left abroad. But as of now we have issued the lookout notice. We are questioning his driver, Narendra Chaudhary, who we have taken in our custody this (Thursday) afternoon," said Nitesh Chhetia, the Investigating Officer of the case.

According to Chhetia, a three-member Special Investigating Team (SIT) has been formed to investigate the case.

"The team includes Ramesh

Desai, the Deputy Superintendent of Police Mehsana as the supervising officer, Janak Rao, a local crime branch police sub-inspector as the assisting officer and Ghetiya as the investigating officer."

The IELTS scam came to light when four candidates from Mehsana — Neil Patel, Dhruv Patel, Urvesh Patel and Swanendra Patel — and two others were caught illegally crossing the freezing St Regis river from Canada into the US on April 28 when their boat began sinking and were rescued by the American police.

The said IELTS exam took place in Navsari on September 25, 2021, by the Planet EDU Ahmedabad.

According to police, Chaudhary, who hails from Sargasan in Gandhinagar, is said to be the link between the students and the others involved in the case.

Three accused, Gokul Menon, Sawant Fernandes and Sunny Patel, were taken into judicial custody earlier this month from Ahmedabad for their alleged role in helping four persons from Mehsana's villages fake their IELTS scores and immigrate illegally to the US from Canada.

Menon and Fernandes were the proxy writers in the IELTS exam which took place in Navsari on September 25, 2021, and Patel was the invigilator from the Planet EDU Ahmedabad.

As per the FIR (September 4), the two rooms which were booked in Hotel Fun City in Navsari from September 24 - September 26 in 2021, accommodated Amit Chaudhary and Narendra Chaudhary, along with two girls from Mizoram, while the IELTS exam was held in the same hotel. Narendra Chaudhary is not among the 45 booked in the FIR.

Surat man held for 'strangling wife to death'

SURAT POLICE Thursday arrested a 34-year-old man for allegedly strangulating his wife to death.

According to police, the incident happened on September 13 when the accused, Prakash Vasava (34), a resident of Bombay colony in the Adajan area, allegedly strangulated his wife Usha Vasava (32) following a quarrel. The couple has three children and Usha works as a domestic help while Prakash is currently unemployed.

Police said a quarrel erupted between the couple on September 13 when Prakash demanded his wife to prepare food while she was taking rest. The next morning, Prakash informed police about his wife's death and the Rander police sent to the body to New civil hospital for post-mortem. "On Wednesday evening, the post-mortem report arrived which cited the cause of death as strangulation. The accused went missing Wednesday and even his mobile phone was switched off," said Crime branch police inspector LD Vaghadia. On Thursday afternoon, the crime branch officials got a tip off that Prakash had reached his house from where he was arrested.

AMC suspends development permission of building after 7 killed in lift collapse

THE AHMEDABAD Municipal Corporation Wednesday suspended the development permission of the Ador Aspire-2 building in Gulbai Tekra, where seven labourers were killed when an elevator of the under-construction building collapsed, citing the violation of labour safety provisions.

"There are provisions with regard to labour safety stated in the Comprehensive General Development Control Regulations (CGDCR) 2017 issued by the Gujarat Government. The incident which happened on Wednesday morning violated the labour safety rules," said an Estate department official from the West zone of AMC.

"Once it becomes clear who (assigned architect, supervisor, structural engineer, builder) was responsible for the negligence at the site, and what went wrong, where the violation happened exactly, further decision will be

taken by the Deputy Municipal Commissioner of the West Zone," added the AMC official.

"We have sent notices to the structural engineers and the builders to call them for investigation. There are more than one builder involved, the investigation is going on. As per the statement by Pankaj, the injured under treatment in Sola Civil Hospital, he and Rajmal (dead), were working on the sixth floor. They heard a thud, and due to the crashing sound, they also fell, on the open/outer

side of the building," said VJ Jadaia, the Investigating Officer.

Jayesh Khadia, chief fire officer, told mediapersons on Wednesday, that no information was received about the incident. "We learnt about the incident from media reports and the phone calls received from media persons. Hence, I have reached the spot to check what has happened. There has been no official communication or information shared by the developers or any other agency," Khadia said.

AMC-run medical college to be named after Modi

Ahmedabad: The Ahmedabad Municipal Corporation (AMC), in its standing committee meeting Thursday, approved the renaming of the civic body-run medical college as 'Narendra Modi Medical College'. The college is affiliated to

Sheth LG General Hospital.

The proposal to rename the college was sent by the executive committee of AMC-MET on September 14 and a resolution was passed to this effect. This is the second public facility in the

city named after Modi—Motera's Sardar Patel stadium was the first. The college, inaugurated in 2009 by the then Chief Minister Narendra Modi with 150 MBBS seats, now stands at 200 seats for the undergraduate degree. ENS
