Pursuant to Regulation 30 and Para A of Part A of Schedule III of the SEBI Listing Regulations we hereby inform that the BSE Limited ("BSE") vide their email dated 13<sup>th</sup> December 2024, imposed a fine of Rs.5,000/- (Rupees Five Thousand only) for delay in disclosure of Related Party Transactions under Regulation 23(9) of SEBI Listing Regulations in XBRL Format.

The disclosure of Related Party Transactions under Regulation 23(9) of SEBI Listing Regulations for half year ended 30<sup>th</sup> September 2024 was submitted along with the financials of the Company on 24<sup>th</sup> October 2024 within 30 minutes of conclusion of Board Meeting. However, XBRL submission of the same was made on 25<sup>th</sup> October 2024 i.e. within 24 hours of conclusion of Board Meeting.
