Sub: CEO succession

Pursuant to Regulation 30 read with Schedule III to SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations'), we wish to inform you that after nearly 8 years of strong growth under the leadership of Mr. Anand Kripalu, the current Managing Director & Chief Executive Officer of the Company, board of directors at its meeting held today i.e. December 10, 2020, have *inter-alia*, approved the following succession plan.

- 1) Effective from April 1, 2021 Ms. Hina Nagarajan has been appointed as Chief Executive Officer Designate, who will closely work with Mr. Anand Kripalu upto June 30, 2021. Thereafter, Mr. Anand Kripalu will step down as the Managing Director & Chief Executive Officer and cease to have Board responsibilities in the Company.
- 2) Effective July 1, 2021 Ms. Hina Nagarajan will assume office as the new Managing Director & Chief Executive Officer of the Company in accordance with the applicable law and upon receipt of necessary approvals.

During his tenure, Mr. Kripalu has led the transformation and growth of United Spirits Limited (USL), with considerable improvement in operating performance – margin growth, working capital and cash generation. Following Diageo's acquisition of USL in 2013, he led the full integration of USL, reigniting the market's portfolio strategy.
