Sub: Confirmation as regards not being a 'Large Corporate'

Pursuant to SEBI circular SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018, which was superseded by SEBI Circular SEBI/HO/DDHS/P/CIR/2021/613 updated as on April 13, 2022 in respect of fund raising by the issuance of Debt Securities by large entities whereby amongst others, the listed entities which are identified as "Large Corporate" within the meaning as specified in the said circular, are required to file an Annual Disclosure within 45 days from the beginning of the Financial Year giving certain information.

Sky Gold Limited, ('the Company'), meets only Two of the three conditions required to be a large corporate viz:

- a. The Company's equity shares are listed on BSE Limited and National Stock Exchange of India Ltd (NSE) and;
- b. The Company has an outstanding long-term borrowing of Rs. 100 crore or above

However, it does not meet the third condition w. r. t. Credit rating i.e.:

- a. the Company should have a credit rating of "AA and above", where credit rating shall be of the unsupported bank borrowing or plain vanilla bonds of an entity, which have no structuring/ support built in; and in case, where an issuer has multiple ratings from multiple rating agencies, the highest of such ratings shall be considered for the purpose of applicability of this framework.
