# **BJP indulging** in malicious propaganda over 'rath yatra' clearance in **Bengal: TMC**

West Bengal : The Trinamool Congress on Friday accused the BJP of indulging in "malicious propaganda" over denial of permission to hold its 'rath yatra' in West Bengal, asserting that the ruling party has nothing to do with providing such clearance. The All India Trinamool Congress said on Twitter that the state government has not denied permission to the BJP's programme in contrary to the claims of the saffron party. "GoWB has not denied permission to any Yatra, as claimed by @ BJP4Bengal. They are indulging in malicious propaganda with neither substance nor truth. "BJP must show material evidence of GoWB denying permission to their Yatra. This is BJP's attempt to claim victimhood," the AITC said on the microblogging site. The BJP has decided to take out rath vatras across the state in February and March to drum
