The details of the Statutory Auditor, as required under SEBI Circular CIR/CFD/CMD/4/2015 dated September 9, 2015 is given below;

- 1) Reason of Change: Pursuant to the provisions of Section 139 of the Companies Act, 2013 read with rules made thereunder, an audit firm can be appointed as statutory auditors for a maximum of 2 terms of 5 consecutive years. Retiring Auditors hold office until the conclusion of the 10th Annual General Meeting of the Company and are not eligible for re-appointment for another term as per Section 139 of the Companies Act, 2013. In this regard, the Board recommended the appointment of M/s. Walker Chandiok & Co LLP, Chartered Accountants (Firm Registration No. 001076N/N500013) as the Statutory Auditors for approval of the Members at the ensuing 10th Annual General Meeting of the Company.
- 2) Date and term of Appointment: The appointment of M/s. Walker Chandiok & Co LLP, Chartered Accountants (Firm Registration No. 001076N/N500013) as Statutory Auditors of the Company shall be for a term of 5 consecutive years from the conclusion of the 10th AGM till the conclusion of 15th AGM of the Company.
