**ORDER**

An application under section 13(4) of the Companies Act, 2013 (hereinafter referred to as “the Act”) was filed on 22/09/2023 through e-Form No. INC-23 bearing SRN : AA5200652 by M/s. Likhami Consulting Limited (hereinafter referred to as “the applicant company”) for confirmation of the alteration of Clause – II of the Memorandum of Association of the applicant company for shifting of its registered office from the State of West Bengal to the state of Maharashtra.

2. As per sub-sections (4) and (5) of Section 13 of the Companies Act, 2013 read with the Notification No. GSR 955(E) dated 27<sup>th</sup> July, 2017 of Ministry of Corporate Affairs, the Companies are required to file application under the provision of section 13(4) of the Act before the Regional Director for shifting of its registered office from one State to another. In pursuance of this, the above case has been filed and placed before the Regional Director, Eastern Region, Kolkata for disposal.

3. The company is listed company, it has physically submitted affidavit in respect of creditors and a list of creditors (Nil) as on 21.08.2023. The affidavit so submitted was signed on 21.08.2023 whereas, the date of purchase of affidavit was 15.09.2023 which indicate that the affidavit was executed on a stamp paper purchased subsequent to signing of affidavit. Further, the affidavit so submitted was signed only by one director and company secretary and not by second director as clearly intimated to the company. Thus, the affidavit submitted by the company was neither executed properly nor was in accordance with the requirements of Rule 30(2) of the Company (incorporation) Rules, 2014.

4. **NOW THEREFORE**, in exercise of the powers delegated on the undersigned under section 13(4) of the Companies Act, 2013 r/w Government of India, Ministry of Corporate Affairs' Notification No. S.O. 4090 (E) dated 19.12.2016, in view of reason explained in Para No. 3 as above, the said application is rejected with liberty to the company to file application afresh, if desired.
