# SC Lifts U'khand HC Stay on 30% Quota for Women in State Services

Petitioners said horizontal reservation based only on domicile of the state was arbitrary

New Delhi: The Supreme Court on Friday lifted a stay imposed by the Uttarakhand High Court on a government order that had provided 30% horizontal reservation in public services for women domiciled in the state.

The High Court stayed the state government order on August 24. A division bench comprising Justices S Abdul Nazeer and V Ramasubramanian issued notices on an appeal by the Uttarakhand government against the High Court order. Solicitor General Tushar Mehta appeared on behalf of the state government. The Uttarakhand Public Service Commission had, through a notification dated August 10, 2021, advertised the Uttarakhand Combined State (Civil) Pravar Subordinate Service Examination 2021, and listed 224 vacancies for various posts in about 31 departments.

According to the notification, the 30% horizontal reservation did not apply to women who were not domiciled in the

The stay was challenged before the High Court, with the petitioners arguing that horizontal reservation based only on domicile of the State was arbitrary, illegal and in violation of Article 14, 16, 19 and 21 of the Constitution. They challenged the state government orders dated July 18, 2021, and July 24, 2021, as well as Clause 8 of the advertisement dated August 10, 2021. The petitioners further contended before the HC that the government order created an Unreserved Uttarakhand Mahila Category which provided lower cut-off marks for women of the state to pass the preliminary examination.

The reservation, they said, deprived them of the opportunity of appearing in the main examination as they couldn't clear the preliminaries despite getting more marks than women who could make use of the reservation. The petitioners further argued that the state government did not have the power to provide domicile-based reservation. The plea before the High Court also contended that the Indian Constitution allowed for reservation based on domicile only by a law enacted by Parliament. The government order was stayed by the High Court, allowing the petitioners to appear in the main examination. Aggrieved, the Uttarakhand government appealed against the decision in the apex court.

# Morbi Municipality CEO Suspended

Gandhinagar: Gujarat government has suspended Morbi municipality chief executive officer Sandeep Singh Zala days after the collapse of a cable suspension bridge, which killed at least 135 people. Zala is the first government employee to have come under the scanner after the tragedy last Sunday, just days after private company Oreva reopened the century-old hanging bridge after renovation.

The suspension order issued late on Thursday noted that retaining Zala in active duty would be against public good in the backdrop of an inquiry constituted against responsibility details of Morbi municipality. Oreva company that was responsible for renovation and maintenance of the bridge, and the agency that

carried out the renovation. Zala has been placed at the zonal head quarters at Rajkot. Police have already questioned him as a part of evidence collection process in the case, a police officer connected with the case told ET. "We are investigating the case thoroughly and in case we find any criminal culpability we shall go ahead with arrest," the officer said.

Zala, it may be remembered, had told media that the hanging bridge was reopened to public without informing the municipality. While the inauguration of the bridge by Oreva owner Jyotsuk Patel was extensively covered by the media in Morbi, Zala had claimed that he had learnt about the event only through media. Meanwhile, a group of activists were allegedly stopped from sitting for a fast and demonstration at Morbi on Friday. They demanded that senior government officials named in the FIR (first information report) filed in the bridge collapse case and be investigated accordingly.

Nilesh Aravdia, social activist and a former member of Patidar agitation, alleged that the state government has been trying to save the senior functionaries of Morbi municipality.

On Saturday the meeting discussed 86 seats from 15 districts including Gandhinagar city and district, Mehsana, Amreli, Botad, Ahmedabad city and district, Bhavnagar City and district, Kheda, Panchmahal, Navsari, Bharuch, Jamnagar city and District and Devbhumi Dwarka. On Saturday 77 remaining seats from 13 districts are expected to be discussed. A panel of three to four names of prospective candidates which is being prepared at these meetings will be forwarded to the central parliamentary board.

# CSIR's Bhatnagar Award Sent to 37 Scientists by Post

Award for 2019, 2020 and 2021 sent by post citing pandemic delays

New Delhi: In a departure from convention, the most coveted of national science and technology awards in the country — the Shanti Swarup Bhatnagar awards — have been sent to nearly 37 awardees by post instead of conferring it on them at a high-profile award ceremony. ET gathers that the SSB awards for 2019, 2020 and 2021 have been sent by the Council for Scientific and Industrial Research (CSIR) to the awardees late last month by post, citing pendency due to Covid-19.

The last ceremony for SSB awards was held in February 2019. "The prizes have been sent by post to the recipients of SSB prize for 2019, 2020 and 2021 as they have been pending due to the Covid-19 pandemic," the CSIR confirmed in an emailed response to ET's queries. Twelve awardees were announced by the CSIR for 2019, 14 for 2020 and 11 for 2021.

While the SSB award ceremony was traditionally held on an annual basis, over the last few years, it is scheduled every 2-3 years instead and awards of various years are conferred at a single ceremony. "Since there has been considerable delay in presenting the awards for the past three years owing to the unprecedented Covid-19 pandemic the prizes were sent to the winners usually announces the names of the SSB awardees on September 26 every year — its foundation day. Vatsala Thirumalai, the recipient of the SSB award in 2020 for her work on neural circuits that generate movement, has also received the award by post last week. She said while she was very happy to have received it, the absence of the much-awaited award ceremony was disappointing.

She said other award ceremonies including those delayed due to the pandemic were being held in New Delhi such as the National Film awards or high-level gatherings with award winning sports persons.

**Trinamool Objects to 'Sabka Saath Sabka Vikas' Slogan Use in Parl Panel Meet**

New Delhi: The Trinamool Congress has objected to the use of the slogan 'Sabka Saath Sabka Vikas' by the Ministry of Development of North Eastern Region in a recent meeting of the parliamentary standing committee of home affairs. Trinamool called the usage of the slogan in this context an insult to the value of non-partisanship on which parliamentary panels are expected to conduct their meetings. Trinamool insiders said the party will write to all ministries to re-

frain from using 'political slogans' in their presentations made to members.

Members of the newly constituted committee said the objection came from Trinamool MP Derek O'Brien who was supported by MPs of at least three other opposition political parties. The presentation showcased the work the government would be doing for the development of the northeastern states, and it had references to 'Sabka Saath Sabka Vikas' — the slogan used by the BJP in Lok Sabha elections in 2014 — to refer to the principle driving its approach. It was shown to members at the committee's meeting on Thursday.

# China's Xi Meets Germany's Scholz, Calls for Ukraine Peace Talks

Beijing: In a much-scrutinised meeting Friday with visiting German Chancellor Olaf Scholz, Chinese President Xi Jinping called for peace talks between Russia and Ukraine and warned against the conflict going nuclear.

The German leader is in Beijing for a one-day visit that has drawn criticism over China's tacit support for Russia, lingering controversies over economic ties and human rights issues. It comes after Xi further cemented his authoritarian rule at a major Communist Party congress last month.

Scholz's visit reflects the importance of Germany's trade ties with China, the world's second-largest economy, particularly in the auto and manufacturing sectors. Mercedes-Benz alone sold 758,863 cars in China last year, more than in any other country, according to company figures.

Scholz, who is traveling with several top German business leaders, received a formal welcome from Xi, who was recently reappointed head of the ruling Communist Party for a third term, at the Great Hall of the People in the heart of Beijing.

"At present, the international situation is complex and changeable," Xi was quoted as telling Scholz

## 7 Ministers Rally Support for Ukraine, Suspicion of China

Top diplomats from the world's major industrialised democracies on Friday rallied support for Ukraine in its resistance to Russia's invasion and coalesced around suspicion of China's increasing assertiveness amid a panoply of global crises. Foreign ministers from the Group of Seven nations, wrapping up two days of talks in the historic western German city of Muenster, were set to release a statement asserting common positions on Ukraine, Russia, China and recent developments in Iran and North Korea, officials said. # Binance Helped Iranian Firms Trade \$8 B Despite Sanctions

\$7.8 b of trades were via Iran's crypto bourse Nobitex; revelations come amid US Justice Dept probe into Binance

London: Crypto giant Binance has processed Iranian transactions with a value of \$8 billion since 2018 despite US sanctions intended to cut Iran off from the global financial system, blockchain data show.

Almost all the funds, some \$7.8 billion, flowed through Binance and Iran's largest crypto exchange, Nobitex, according to a review of data from leading US blockchain researcher Chainalysis. Nobitex offers guidance on its website on how to skirt sanctions.

Three-quarters of the Iranian funds that passed through Binance were in a relatively low-profile cryptocurrency called Tron that gives users an option to conceal their identities. In a blogpost last year, Nobitex encouraged clients to use Tron "a mid-tier token to trade anonymously without 'endangering assets due to sanctions'."

The scale of Binance's Iranian crypto flows - and the fact that they are continuing - has not been previously reported.

The new findings come as the US Justice Department is pursuing an investigation into possible violations



of money-laundering rules by Binance, which dominates the \$1 trillion crypto industry with over 120 million users. The transactions put the company at risk of falling afoul of US prohibitions on doing business with Iran, lawyers and trade-sanctions experts said.

In July, Reuters revealed that Binance continued to serve clients in Iran and that the exchange's popularity in the Islamic republic was known inside the company. It was one of a series of Reuters investigations into Binance's troubled history with financial regulatory compliance. The day of that article's publication, Binance said in a blog post that it follows international sanctions rules on Iran and blocks access to the platform to anyone based there. The exchange's billionaire founder, Changpeng Zhao, tweeted: "Binance banned Iranian users after sanctions. I got missed/ found a workaround, then they banned later anyways."

Binance didn't answer detailed questions about the new transactions uncovered by Reuters. In a statement, spokesperson Patrick Hillmann said, "Binance.com is not a US company unlike other platforms that have exposure to these

same US sanctioned entities. However, we have taken proactive steps to limit our exposure to the Iranian marketplaces, working with industry partners and internal tools."

Binance declines to give details of the location or the entity behind its Binance.com exchange. Nobitex didn't respond to questions for this article. Nor did the Tron Network, based in the British Virgin Islands, and its founder Justin Sun.

In August 2022, Binance announced that customers would no longer be able to open accounts and use its services without identification. But since then, the exchange has processed almost \$1.05 billion in trades directly from Nobitex and other Iranian exchanges, according to the Chainalysis data, which runs to November of this year. Since Zhao's tweet in July, Binance has processed around \$80 million in Iranian trades.

Hillmann said in the Binance statement that the company requires full "Know Your Customer" checks for all users and residents of Iran are prohibited from opening or maintaining an account. We are continually updating processes and technology as we learn about new risks and potential exposures. Reuters

## Apple Pauses Hiring for Roles Outside R&D

Apple Inc has paused hiring for many jobs outside of research and development, an escalation of an existing plan to reduce budgets heading into next year, according to people with knowledge of the matter.

The company took the step last month, ahead of a quarterly earnings report when it said that growth would slow in the holiday period. The pause generally doesn't apply to teams working on future devices and long-term initiatives, but it affects some corporate functions and standard hardware and software engineering roles, said the people, who asked not to be identified because the move isn't public.

Apple joins other tech giants in tapping the brakes on hiring, a response to sluggish consumer spending and higher interest rates. The iPhone maker has fared better than many tech peers this year, but it's still facing an industry-wide slowdown for smartphones and computers.

Apple said that it continues to hire, "but given the current economic environment we've taken a very deliberate approach in some parts of the business." "We want to be thoughtful and make smart decisions that enable us to continue fueling innovation for the long term," the California-based firm said. Bloomberg

## Iran President Takes Aim at Biden Pledge to 'Free' Iran

Tehran: Iran's President Ebrahim Raisi on Friday ridiculed a vow by US President Joe Biden to "free" Iran, as weeks of protests in the Islamic republic show little sign of abating.

Campaigning for term elections in the US, Biden had on Friday said: "Don't worry, we're gonna free Iran. They're gonna free themselves pretty soon."

Iran has for more than six weeks been gripped by protests sparked by the death last month of Mahsa Amini after her arrest by the morality police for a breach of the country's strict dress code for women. Addressing a gathering commemorating the November 1979 takeover of the US embassy in Tehran by students, Raisi said: "the US says it wants to free Iran, but I must tell you that Iran liberated itself 43 years ago and will no longer submit to you." स्थाई किया जाए। सभी महिला कर्मचारियों को डिलीवरी के समय तीन महीने की छुट्टी दी जाए। निकाले गए कर्मचारियों को वापस पर नौकरी पर रखना, कर्मचारियों को उपचार के लिए कैंसर कार्ड की

सुविधा, सफाई कर्मचारी के कार्य के दौरान या बाद में मृत्यु होने पर आश्रितों को 10 लाख रुपये आर्थिक सहायता मिलना, सेलरी खाते पर लोन की सुविधा दिया जाना, सफाई कर्मचारियों के 58 वर्ष होने के बाद उनके आश्रितों को नौकरी और वृद्ध कर्मचारियों को पांच लाख रुपये दिए जाना समेत अन्य मांगें हैं।

फेडरेशन के नगर अध्यक्ष सुनील टॉक का कहना है कि मांगें नहीं माने जाने तक हड़ताल जारी रहेगी। इस बारे में नोएडा प्राधिकरण के ओएसडी इंदु प्रकाश का कहना है कि फेडरेशन की करीब 90 प्रतिशत मांगों पर सहमति जता दी है। इसके बाद भी वह काम पर लौटने को तैयार नहीं है।

## फिल्म सिटी की प्री बिड बैठक सात को लखनऊ में

ग्रेटर नोएडा (एसएनबी)। यमुना प्राधिकरण के सेक्टर-21 में प्रस्तावित फिल्म सिटी को लेकर प्री बिड बैठक सात नवम्बर को लखनऊ में होगी। बैठक में फिल्म उद्योग से जुड़ी 20 बड़ी कंपनियों भाग लेंगी। बैठक में कंपनी टेडर और कंसेशन एग्रीमेंट को लेकर चर्चा होगी। अगर कोई सुझाव आता है तो उस पर भी अमल किया जाएगा।

## बिल्डर प्रोजेक्ट : अतिरिक्त मुआवजा जमा कर रजिस्ट्री करा रहे हैं खरीदार

ग्रेटर नोएडा (एसएनबी)। यमुना प्राधिकरण के अंतर्गत बिल्डर प्रोजेक्ट के खरीदारों ने 64.7 प्रतिशत अतिरिक्त मुआवजा जमा कर रजिस्ट्री कराना शुरू कर दिया है। एटीएस परियोजना में 91 खरीदारों ने यह पैसा जमा कर दिया है। करीब 70 खरीदारों ने रजिस्ट्री करा ली। यमुना प्राधिकरण में बिल्डर अपना बकाया पैसा जमा नहीं कर रहे थे। इसके चलते प्राधिकरण ने कंपलीशन सर्टिफिकेट नहीं दिया था। इसका खमियाजा फ्लैट खरीदारों को उठाना पड़ रहा था। प्राधिकरण ने पिछली बोर्ड बैठक में खरीदारों को राहत देते हुए एक प्रस्ताव पास किया था। जिन परियोजनाओं का आंशिक पूर्णता प्रमाण पत्र जारी हो चुका है। खरीदारों की रजिस्ट्री नहीं हो रही उन्हें रजिस्ट्री कराने का मौका दिया जाएगा। खरीदार को 64.7 प्रतिशत का अतिरिक्त मुआवजा जमा करना होगा। पैसा जमा करते ही अनुमति मिल जाएगी। एटीएस परियोजना के 91 खरीदारों ने अपना अतिरिक्त मुआवजा करीब 17 करोड़ जमा कर दिया है। इसके बाद प्राधिकरण ने रजिस्ट्री करने की अनुमति दे दी है। करीब 70 खरीदारों ने रजिस्ट्री करा ली है।

## डीएम के आदेश की अवहेलना कर खुले निजी स्कूल

ग्रेटर नोएडा (एसएनबी)। दिल्ली-एनसीआर में बढ़ते प्रदूषण के चलते जिले के सभी कक्षा एक से आठ तक के सरकारी व गैर सरकारी स्कूल जिलाधिकारी ने बंद कर दिए थे। सिर्फ ऑनलाइन पढ़ाई के निर्देश दिए थे। जिलाधिकारी के आदेश की अवहेलना कर ज्यादातर निजी स्कूल खुले रहे। सुबह सड़कों पर स्कूली बसें दौड़ रही थीं। छोटे-छोटे बच्चे पैदल भी स्कूल जा रहे थे। कुछ स्कूल संचालकों का कहना है कि देर रात आदेश मिला था इसलिए अभिभावकों को सूचना नहीं दी जा सकी थी।

गौतमबुद्धनगर में प्रदूषण से लोगों का बुरा हाल है। तीनों प्राधिकरण व जिला प्रशासन ने सभी तरह के निर्माण कार्यों पर

रोक लगा दी है। कक्षा एक से 12 तक स्कूलों को बंद कर ऑनलाइन पढ़ाई के निर्देश दिए थे। सरकारी स्कूल तो बंद हो गए लेकिन प्राइवेट स्कूलों ने जिलाधिकारी के आदेश का पालन नहीं किया। जनपद के सभी नामीगिरामी स्कूल रोजाना की तरह खुले रहे। आश्चर्य तो इस बात का है कि प्ले स्कूलों में भी अभिभावक बच्चों को लेकर पहुंच रहे थे। जिसका बच्चों के स्वास्थ्य पर बहुत ही बुरा असर पड़ रहा है। उधर प्रदूषण नियंत्रण बोर्ड की टीमों ने भी शहर के कई सेक्टरों का दौरा किया और निर्माण कार्यों को बंद कराया। ज्यादातर सेक्टरों में निजी मकान बन रहे हैं। ग्रेटर नोएडा प्राधिकरण ने शुक्रवार को दमकल विभाग की गाड़ियों से सड़कों पर पानी का छिड़काव कराया।

## गंभीर प्रदूषण की चपेट में शहर, रविवार को राहत मिलने के आसार

■ हेमन्त बंसल गाजियाबाद। एसएनबी शहर लगातार गंभीर प्रदूषण की चपेट में है। शुक्रवार को गाजियाबाद शहर का एयर क्वालिटी इंडेक्स (एक्यूआई) बृहस्पतिवार के एक्यूआई 416 से मामूली कम 413 दर्ज किया गया। फिर भी प्रदूषण का स्तर 'गंभीर' श्रेणी में रहा। ऐसे में लोगों को आंखों में जलन व सांसों में घुटन महसूस हो रही है। उत्तर प्रदेश प्रदूषण नियंत्रण बोर्ड (यूपीपीसीबी) के क्षेत्रीय अधिकारी का कहना है कि ठंड व हवा की गति कम होने से प्रदूषण ठहरा हुआ है। रविवार को हवाएं कुछ तेज होने का पूर्वानुमान है, तभी प्रदूषण से कुछ राहत मिलने के आसार बनेंगे। वहीं जिला प्रशासन ने कमीशन फॉर एयर क्वालिटी मैनेजमेंट (सीएक्यूएम) के निर्देश पर ग्रेडेटेड रेस्पॉन्स ऐक्शन प्लान (ग्रेप) की श्रेणी -4 के तहत कुछ एहतियाती कदम उठाए हैं। जिनमें बीएस-6 से नीचे के डीजल वाहनों के परिवहन पर रोक व औद्योगिक क्षेत्रों में निर्बाध विद्युत आपूर्ति के निर्देश शामिल हैं। जिलाधिकारी राकेश कुमार सिंह ने बताया कि औद्योगिक क्षेत्रों में निर्बाध विद्युत आपूर्ति के निर्देश इसलिये

दिए गए हैं ताकि औद्योगिक क्षेत्रों में डीजल जनरेटर चलाने की नौबत न आए। आवश्यक वस्तुओं को लाने वाले वाहनों को रोक से छूट रहेगी। सीएक्यूएम ने जिन निर्माण परियोजनाओं पर प्रतिबंध नहीं लगाया है उनको डस्ट उत्सर्जन को रोकथाम व पानी के छिड़काव करते रहने के निर्देश दिए गए हैं। लोग निजी वाहनों के बजाय पब्लिक रविवार को हवा की गति बढ़ने की उम्मीद, तब छटेगा धुआं सीएक्यूएम के निर्देश पर ग्रेप की श्रेणी-4 के तहत प्रशासन ने भी उठाए एहतियाती कदम ट्रांसपोर्ट का प्रयोग करें। सभी स्थानीय निकायों को निर्देश दिए गए हैं कि वे अपने पास उपलब्ध एंटी स्मोक गन व स्पिंकलर्स का अपने क्षेत्रों में निरंतर इस्तेमाल करें। गौरतलब है कि वसुंधरा में शुक्रवार को एक्यूआई सर्वाधिक 449 मापा गया। लोनी में यह आंकड़ा 408 रहा। वहीं इंदिरापुरम में व संजयनगर में एक्यूआई क्रमशः 396 व 398 रहा। गौरतलब है कि शून्य से 50 के बीच

एक्यूआई को 'अच्छा', 51 से 100 को 'संतोषजनक', 101 से 200 को 'मध्यम', 201 से 300 को 'खराब', 301 से 400 को 'बहुत खराब' और 401 से 500 को 'गंभीर' माना जाता है। यूपीपीसीबी के क्षेत्रीय अधिकारी उत्सव शर्मा का कहना है कि हवा की गति कम होने से अभी एक्यूआई में सुधार के आसार नहीं हैं। रविवार को कुछ तेज हवाएं चलने का अनुमान है तब प्रदूषण से कुछ राहत मिल सकेगी। हवा की कम गति प्रदूषण को दूर नहीं ले जा पा रही है। इससे हवा की गुणवत्ता बिगड़ रही है। पराली जलाने और स्थानीय कारकों समेत अन्य मौसम संबंधी कारकों से भी हवा की गुणवत्ता में गिरावट आई है। उत्तर-पश्चिम दिशा से चलने वाली हवा, दूसरे राज्यों में जलाई गई पराली का धुआं भी दिल्ली-एनसीआर तक ले आई, अब हवा की गति मंथर है, जिससे धुआं ठहर गया है। जब तक हवा की गति तेज नहीं होती प्रदूषण स्तर में अपेक्षित सुधार होने की संभावना नहीं है। शहर के वरिष्ठ ईएनटी विशेषज्ञ डा. बीपी त्यागी के अनुसार लंबे समय तक प्रदूषण में रहने से न केवल अस्थमा बल्कि हृदय रोगियों, बुजुर्गों व बच्चों की दिक्कतें बढ़ सकती हैं। उन्होंने सलाह दी है कि बाहर निकलते समय मास्क जरूर पहनें।

जयपुर (एसएनबी)। जयपुर में एक युवक ने अपने पूरे परिवार को मृत के घाट उतार दिया। पहले खेत में पिला पर कुल्हाड़ी से चार बार चार बार मार कर मृतक किया। घाट को पारस वेदा गोलिया मिला दी। फिर युवक को एक के बाद एक पानी की टंकी में फेंक दिया। फिर खुद भी सुसाइड कर लिया। इस घटना में कुल पांच लोगों को मौत हो गई। जयपुर जिले के लोहावट थाना के सीआर वडी प्रसाद ने बताया कि घटना लोहावट के पीलाव गांव की है। गुजरात श्याम किसान शंकर लाल (38) ने अपने पिता सोनाराम (65) पर कुल्हाड़ी से हत्या कर घायल कर दी गई। सोआइ वडी प्रसाद ने बताया कि शंकर लाल ने का आदि था। देव कुल लोगों ने अस्पताल पहुंचाया। जहां देर तक इलाज के दौरान उसकी मौत हो गई। शंकर लाल खेत में पिला को मार कर पर चुड़ा। परिवार के खाने में नंद की गोलिया मिला दी। इससे सभी बेहोश हो गए। उससे सबसे पहले अपनी मां चंपा (55) को चार में चार पानी के टंकी में फेंक दिया। चंपा के पास वेदा लक्ष्मण (14) सो रहा था। उसे भी उसने टंकी में फेंक दिया। सुसाइड 5 बजे पानी मैन के पास उसका छोटा बेटा दिनेश (8) सो रहा था। उसे भी टंकी में फेंक दिया। फिर पर से निकल कर कुछ दूर अपने मामा के घर के टंकी में कूद कर आत्महत्या कर ली। सुबह लोग पर पहुंचे तो परिवार के शव पानी के टंकी में ही रहे थे। पुलिस को घटना की सूचना दी गई। सीआइ वडी प्रसाद ने बताया कि शंकर लाल ने का आदि था। अफीम का नशा करता था। इसकी सचनी से अनजान थी। सूचना के बाद पूरे गांव में ससनी फैल गई, मकै पर एमरजेंसी टॉप भी पहुंची।

जयपुर (एसएनबी)। प्रदेश के सवाई माधोपुर जिले में स्थित प्रसिद्ध रणथंभौर अभयारण्य से एक बार फिर साढ़े छह साल के युवा बाघ टी-110 को बुधवारवार को कोटा के मुकुंदरा टाइगर रिजर्व के लिए रवाना कर दिया गया। इससे पहले 16 अक्टूबर को सूरिकमा की टी-113 को शिफ्ट किया गया था। बाघ टी-110 को टैंगुलाज करने के लिए नव विभाग की टीम व अधिकारी पिछले कई दिनों से प्रयास कर रहे थे। ऐसे में नव दिवस के प्रयास विफल होने के बाद आखिरकार बुधवारवार को कोटा के मुकुंदरा टाइगर रिजर्व लाया गया। इसके बाद रणथंभौर के 4 पशु चिकित्सकों की टीम ने रणथंभौर पार्क की मौजूदगी में बाघ के स्वास्थ्य की जांच कर उसे फिजिकली बंद कर होश में लाया गया। बाघ के होश में आने के साथ ही बाघ को मुकुंदरा टाइगर रिजर्व कोटा के लिए रवाना कर दिया। बाघ टी-110 अब मुकुंदरा में एमपी-5 के नाम से जाना जाएगा। मुकुंदरा में इस समय बाघिन एमपी-4 अकेली युवा रही है। करीब 42 महिलाओं के बाद नव बाघ के साथ आने से बाघों के कुटुम्ब में इजाजत नहीं होने की उम्मीद जग है। कई दिनों से मध्यकत कर रही नव विभाग की टीम को आखिर बुधवारवार सुबह वाट-110 वालीटी रेंज के देवपुरा नके से कुछ दूर गाजीपुर चौकी के पास खुले स्थान पर दिखाई दिया। यह बाघ पिछले कई दिनों से इसी इलाके में दिखाई दे रहा था। बाघ के खुले में आते ही टीम ने इसे ड्राई फायर कर बेहोश किया और कुछ ही देर में बेहोश होते ही टीम में मौजूद डॉ. सीमा मीना, डॉ. राजीव गर्ग, डॉ. अरविंद माधुवी डॉ. जै. तेजेंद्र सिंह ने इसका स्वास्थ्य परीक्षण कर वजन करने के साथ आउटवैक सैलत किया। बाघ ने इसकी टेडिंग के लिए गले में रेडियो कलिया लगाया था। करीब 20 मिन्ट की प्रक्रिया के बाद उसे फिजिकली बंद कर बाघ व इन्वैकेशन लगाया गया। कुछ ही देर में बाघ होश में आते ही विभाग का कानिपल बाघ को लेकर वहां से रवाना हो गई। नव विभाग ने पूर्व में रणथंभौर से शिफ्ट करने के लिए

चाह बाघों को विधित्त किया था। इसमें से एक बाघ टी-113 को 16 अक्टूबर को सूरिकमा में शिफ्ट किया जा चुका है। अब नव विभाग ने बाघ टी-110 को भी टैंगुलाज कर मुकुंदरा टाइगर रिजर्व के लिए भेज है। बाघ विशेषज्ञों के अनुसार मुकुंदरा भेजा गया बाघ टी-110 रणथंभौर की बाघिन टी-69 का बेटा है। इसका पिता टी-65 है। खंडार वन क्षेत्र की आग चौकी के पास जन्मे इस साढ़े छह साल के बाघ ने करीब 46 साल का समय मां के इलाके में कटा, लेकिन जवान होने के साथ ही इस पर दूसरे नव बाघों का दबाव आते ही तेजेंद्र इन्वैकेशन छोड़ कर अपने लिए नव क्षेत्र तलाशना शुरू कर दिया। इन्वैकेशन छोड़ माह यह बाघ बाहर की तरफ फलान कर रहे लगा और इन्वैकेशन हुआ बंगलौली वन क्षेत्र पहुंचा। यहाँ पर भी जंगल नहीं मिन्ते के कारण इस बाघ ने वृद्धि चिले के जंगलों की तरफ पकड़ती और तीन साल की उम्र में यह भटकाव हुआ सखानवत तक चला गया, लेकिन इसे वहाँ का वन क्षेत्र नया नहीं आया और कुछ दिन बाद ही वापस रणथंभौर आ गया। तब से यह बंगलौली वन क्षेत्र में ही रहा। वहाँ पर इसने दो बाघिनों के साथ जोड़ा भी बनाया था।
