एक्यआई को 'अच्छा', 51 से 100 को 'संतोषजनक', 101 से 200 को 'मध्यम', 201 से 300 को 'खराब', 301 से 400 को 'बहुत खराब' और 401 से 500 को 'गंभीर' माना जाता है। यूपीपीसीबी के क्षेत्रीय अधिकारी उत्सव शर्मा का कहना हैं कि हवा की गति कम होने से अभी एक्यूआई में सुधार के आसार नहीं हैं। रविवार को कुछ तेज हवाएं चलने का अनुमान है तब प्रदुषण से कुछ राहत मिल सकेगी। हवा की कम गति प्रदूषक कणों को दूर नहीं ले जा पा रही है। इससे हवा की गुणवत्ता बिगड़ रही है। पराली जलाने और स्थानीय कारकों समेत अन्य मौसम संबंधी कारकों से भी हवा की गुणवत्ता में गिरावट आई है। उत्तर-पश्चिम दिशा से चलने वाली हवा, दुसरे राज्यों में जलाई गई पराली का धुआं भी दिल्ली-एनसीआर तक ले आई, अब हवा की गति मंथर है, जिससे धुआं ठहर गया है। जब तक हवा की गति तेज नहीं होती प्रदेषण स्तर में अपेक्षित सुधार होने की संभावना नहीं है। शहर के वरिष्ठ ईएनटी विशेषज्ञ डा. बीपी त्यागी के अनुसार लंबे समय तक प्रदुषण में रहने से न केवल अस्थमा बल्कि हृदय रोगियों, बुजुर्गों व बच्चों की दिक्कतें बढ़ सकती है। उन्होंने सलाह दी है कि बाहर निकलते समय मास्क जरूर पहनें।


