भांडुपमधील अल्पवयीन मुलीला पळवून नेल्याप्रकरणी कठोर कारवाईची मागणी

मंगलप्रभात लोढा यांच्या नेतृत्वाखालील शिष्टमंडळाने घेतली मुंबई पोलीस आयुक्तांची भेट

मुंबई, दि. २६ : प्रतिनिधी
भांडुप येथे राहणाऱ्या एका अल्पवयीन मुलीला दि. ८ मे रोजी त्याच परिसरात राहणाऱ्या एका तरुणाने फूस लावून पळवून नेल्याची घटना घडली असून, याबाबत त्या मुलीच्या वडिलांनी पोलीस ठाण्यात तक्रार दाखल केली आहे. या पाहंभूमीवर कॅम्बिनेट मंत्री व मुंबई उपनगरचे पालकमंत्री मंगलप्रभात लोढा यांच्या नेतृत्वाखालील एका शिष्टमंडळाने नुकतीच मुंबई पोलीस आयुक्तांची भेट घेऊन,



त्यांना एक निवेदन सादर केले आहे. "जिहाद प्रवृत्तीच्या लोकांकडून महाराष्ट्रात 'लहद जिहाद'ची प्रकरणे घडवली जात आहेत. या प्रकरणात गुन्हेगारांना अटक झाली आहे. परंतु, त्याला मदत करणारे, त्याचे आई-वडील आणि अन्य नातेवाईक बाहेर फिरत आहेत. तसेच, या प्रकरणातील पीडित मुलगी अल्पवयीन असून, गुन्हेगार युवक आणि त्याला सहाय्य करणाऱ्या सगळ्यांवर 'पोक्सो' कायदांतर्गत तातडीने कठोर कारवाई झाली पाहिजे," अशी
