To re- consider and approve the requests received for Re-Classification of certain persons from "Promoter and Promoter Group Category" to "Public Category".

The Chairman informed the Board that the Company has received a request letter dated 17^{th} June, 2022 for re-classification from some of the shareholders namely Mr. Arun Dhir, Mr. Tarun Dhir, Mr. Charanjit Lal Dhir, Mr. Prem Dhir, Ms. Sangeeta Dhir , M/s Dhir Exports and M/s Arun Enterprises of the Company holding in aggregate 1364737 equity shares representing 8.13%, seeking re-classification on 17^{th} June, 2022 belonging to the "Promoter and Promoter Group" to re-classify, their shareholding in the Company from the category of 'Promoter and Promoter Group' to the of 'Public' shareholding and removal of their names from 'Promoter and Promoter Group' of the Company subject to the approval of Shareholders.
