It was further informed that the Company engaged Mr. Neeraj Jindal & Associates, Company Secretary in Practice, (Membership No. FCS 8270 Certificate of Practice No.9056) was appointed as the Scrutinizer to scrutinize the voting during meeting and remote e-voting process in a fair and transparent manner.

The Company Secretary conducted the proceedings of the items set out in the Notice along with the object and implication of each resolution.
