Subject: Clarification on media news item under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Sir/Madam,

This is in response to media article published on November 17, 2020 by The Economic Times (e-paper version) regarding investigation order by Hon'ble Delhi High Court (“**the Court**”) order pertaining to alleged data theft by Just Dial Limited (“**the Company**”).

In this regard, we would like to clarify that the aforesaid order was passed *ex parte* and as on date the Company has not been served with a complete set of paperwork. The Company is pursuing all legal remedies in the Court to counter / address absolutely baseless and frivolous allegations filed by Indiamart Intermesh Limited pertaining to launch of its proposed B2B project – JD Mart.

The Company would like to highlight the fact that Indiamart Intermesh Limited are themselves indulging in illegal activities in all possible manner by copying data/content of the Company, cybersquatting, etc. Presence of innumerable webpages on Indiamart Intermesh Limited’s live platforms, bearing the Company’s proprietary content and images bearing the Company’s watermark, has recently come to our notice. The Company is in the process of taking appropriate legal action to safeguard its interests from such malicious activities of Indiamart Intermesh Limited. Further, the Company respects the Court’s order and will be presenting its position before the Court shortly.

The Company’s JD Mart platform’s development is running as per planned schedule – the product demo is already available on the Company’s platforms and the product shall
