- 1. Sales, net of GST for the guarter ended and nine months ended December 31, 2019 increased by 4.1% and 4.2% respectively in comparison to the corresponding period of the previous year sales, net of GST.
- 2 a) Tax expense for the guarter and nine months ended December 31, 2018 is net of prior year reversal of Rs. 897 Lakhs and 1,300 lakhs respectively.
  - b) The Company elected to exercise the option permitted under section 115BAA of the Income Tax Act. 1961 as introduced by the Taxation Laws (Amendment) Act, 2019. Accordingly, the Company has recognized Provision for Income Tax for the guarter and period ended December 31, 2019 and re-measured its opening net Deferred Tax Liabilities basis the rate prescribed in the said section.
- Exceptional Item for the nine months ended December 31, 2018 comprises of profit before tax of Rs. 3,412 Lakhs on the sale of the Company's former factory leasehold land and buildings at Aurangabad, Maharashtra. Exceptional Item for the year ended March 31, 2019 comprises of profit before tax of Rs. 3,412 Lakhs on the sale of the Company's former factory leasehold land and buildings at Aurangabad, Maharashtra which is net off by Rs 361 Lakhs on severance and related expenses with respect to certain organisation structure changes.
- Effective April 1, 2019, the company adopted Ind AS 116 "Leases", applied to all contracts having lease components existing on April 1, 2019 using the modified retrospective method. Accordingly, comparatives for the year ended March 31, 2019 have not been retrospectively adjusted. The Company has measured the Right-of-use asset and lease liability based on the remaining lease period and payments discounted using the incremental borrowing rate as of the date of initial application. The effect of this adoption is not significant on the profit for the period and earning per share.
- 5. The Company has identified 'Personal Care (including Oral Care)' as its only primary reportable segment in accordance with the requirements of Ind AS 108, 'Operating Segments'. Accordingly, no separate segment information has been provided.
- 6. Previous period/year figures have been reclassified, as considered necessary, to conform with current period presentation, where 7. The Statutory Auditors have carried out a Limited Review of the Financial results of the quarter ended December 31, 2019 as
