Subject : Evaluation of the Promoter shareholding structure of GE T&D India Limited

Dear Members of the Board,

1. As you are aware, as on date, GE Grid Alliance B.V. (*formerly Alstom Grid Holding B.V*) holds 6.46% (six point four-six percent) and Grid Equipments Private Limited holds 68.54% (sixty eight point five-four percent) of the paid-up share capital of GE T&D India Limited (“**Company**”).
2. GE Grid Alliance B.V. (*formerly Alstom Grid Holding B.V*) and Grid Equipments Private Limited, being the Promoters of the Company the “**Promoter Group**”, are in the process of reviewing their shareholding structure of the Company, so as to simplify its holding structure and, in this regard, will evaluate and assess their current shareholding in the Company including evaluating the possibility of a minority stake sale by the Promoter Group in the Company.
