The Board was informed that the Company had received request letters each dated August 09, 2021 ("Request Letters") from the following members of the Promoter Group Category ("Persons") requesting their reclassification from 'Promoter Group Category' to 'Public Category' in accordance with the provisions of Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations"):
