MEMORANDUM OF ASSOCIATION

OF

Oriental Carbon & Chemicals Limited.

- 1. The name of the Company is "ORIENTAL CARBON & CHEMICALS LIMITED"
- 2. The Registered Office of the Company will be situate in the State of Gujarat.#
 - 3. The objects for which the Company is established are :-

A. MAIN OBJECTS TO BE PURSUED ON INCORPORATION

(1) To carry on the business of importers, exporters, manufacturers of and dealers in all kinds of Chemicals, heavy, industrial, marine or otherwise including caustic soda, soda ash, chlorine, sulphur, sulphuric acid, alum, chloro-sulphuric acid superphosphates, carbon bisulphide, sodium sulphate, calcium sulphate and other sulphates and all other minerals, drysalters, oleum and all products and by-products thereof any nature or kind whatsoever and to manufacture, process and deal in all or any other articles or things of a character similar or analogous to the foregoing or any of them or connected therewith.

To carry on business of manufacturer of Chemicals.

(2) To carry on the business of importers, exporters and manufacturers of and dealers in all kinds of alkalines, acids, solvents, drugs, tanins, essences, hormes, trace elements and pharmaceutical, photographical, sizing, medicinal chemical, petrochemical industrial and other preparations and articles of any nature and kind whatsoever, waxes natural and synthetic, industrial solvents and pasting agents, extenders, rubber chemicals including vilcanisers, antioxidents, accelerators, reinforcing agents, carbon black, silica, compounds, softeners, blowing agents and special chemical To carry on the business of manufacturers of all kinds of acids, solvents, etc.



substance, plasticizers, oils, paints, pigments and varnishes, dyestuffs, organic or mineral, intermidiate makers and dealers in proprietary articles of all kinds.

To manufacture sales etc.

(3) To manufacture and prepare salt from saline water and to refine, manipulate, import, export and deal in all kinds of salts including chemical salts, sea salts, rock salts, mineral salts and minerals, their derivatives, products, by-products and compounds of any nature and kind whatsoever.

To explore, acquire by lease, and maintain natural deposits of salt etc.

(4) To own, prospect for, explore, acquire by lease, licence, purchase or otherwise, open, work, develop and maintain natural deposits of salt brine,natron, soda, kieselguhr nitrates and other chemical substances of all kinds and to carry on and conduct the business of working and getting and supplying to other person such salts, brine and other substances.

To refine, salt, brine etc. (5) To refine, treat and render merchantable and fit for use natural deposits of salt, brine, natron, soda, kieselguhr nitrates and other chemical substances of all kinds obtained as aforesaid and to manufacture therefrom by any electrolytic metallurgic or others forms of plant or process every kind of chemical and other products and by-products.

To purchase and acquire any mining rights etc.

(6) To purchase take on lease or otherwise acquire any mining rights, mines and lands in India or elsewhere believed to contain metallic, mineral saline or chemical substances, french chalk, china clay, bentonite and other clay, boryles, calcite and such other ingredients including coal, lights, rockphoshate, brimstone, brine, bauxite, rare earths which may seem suitable or useful or for any of the Company's objects and any interest therein and to explore, work, exercise, develop and turn to account the same.

To carry on business of distillers

(7) To carry on the business of distillers, refinery operators, compounders, synthetists, analysts, physicists, reactor operators, gas producers and consumers petrochemicals of all types, prospectors, explorers of oil drillers and miners.

To undertake financial obligations,

(8) To undertake financial and commercial obligations, transactions and operation of all kinds.

To make investment

(9) To invest the moneys in such investment as may be thought proper and to hold sell or otherwise deal with such a investments.

B. OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECT

(10) To carry on business as manufacturers of and dealers in coal-tar, petroleum, natural and syntetic coalgas, refinery gas, fibres and films and all kinds of organic chemical products. To carry on business of manufacturers of coal-tar, petroleum etc.

(11) To fix atmospheric nitrogen by the synthetic ammonia or by any other process and to manufacture its derivatives compounds, products and by products.

To fix nitrogen etc.

(12) To carry on and engage in the business of providing consultative and technical services in designs, construction and engineering of chemical and chemical process plant, and equipment, air and water conditioning and effuent treatment, handling of inflamable liquids and gases and materials, steam and high temperature services project estimating and planning and servicing, prospecting, market survey, safety and fire fighting services as manufacturers of and dealers in equipment, machinery apparatus and special fittings thereof. To carry on business of consultative and technical services.

(13) To carry on the business of importers, exporters, manufactures of and dealers in fertilizers and manures, distillers, dye-makers gas-makers and makers of chemical and idential preparations of all kinds and products made thereof. To carry on business of manufactures of fertilizers etc.

(14) To purchase or otherwise acquire, and undertake the whole or any part of the business, property, rights, assets and liabilities of any Company or person carring on any business which the Company is authorised to carry on, or possessed of or the property or rights suitable for any of the purposes of this Company.

To acquire Property.

(15) To provide for the welfare of employees, ex-employees, Directors ex-Directors of the Company, and the wives and families or the dependents or connection of such persons by building or contributing to the building of houses, dwelling or chawls or by grants of money, pensions allowances, bonus or other payments, or by creating and from time to time subscribing or contributing to provident and other associations, institutions, funds or trusts and by providing or subscribing or contributing towards places of instructions and recreation, hospitals and dispensaries, medical and other attendances and other assistance as the Company shall thinkfit.

To carry, on business of Processing.

(16) To convert, treat or turn to account by any process or method of manufacture, chemical, synthetic or otherwise, or in any other manner, timber, wood, cotton, linters, droppings, cotton waste, cotton seeds, bambo, grass, straw, jute, jute sticks, sisal fibre, flax, hemp, hessian, gunnies, sugar, cane bagasse, asbestos, rags, waste paper, water hyacinth or any kind of pulp or other substance prepared from these or from other vegetables, minerals, chemicals or any other substances and also to prepare, manufacture, cut, spin, weave or knit, fibre, fibres or fibrous materials, filament, yam, cords cloth, whether grey, bleached, unbleached, dyed printed, knotted, looped, creeped, crinkled, or left and such other fabrics and things as may be practicable or deemed expendiant, and deal in or otherwise handle any of the foregoing commodities.

The Authorised Share Capital of the Company is Rs. 15,00,00,000/- divided into 1,49,90,000/- Equity Share of Rs. 10/- each & 1,000 preference Share of Rs. 100/- each, with the rights, privileges & conditions attaching thereto as are provided by the regulations of the Company for the time being with power to increase and reduce the capital of the Company and to divide the Shares in the capital for the time being into several classes and to attach thereto respectively such preferential, qualified or special rights, privileges or conditions as may be determined by or in accordance with regulations of the Company and to vary, modify or abrogate any such rights, privileges or conditions in such manner as many for the time being be provided by the regulations of the Company.
