ORDER

1. This IA 5797/2024 is filed by the IRP praying for deferment of CIRP commencement with effect from 14.08.2024 and also to declare that time lines for CIRP of the CD under the IBC be taken to have commenced from the same date. The Applicant/IRP is also praying for permitting him to issue fresh public announcement calling for claims from the creditors.
2. This CP was admitted by us on 11.06.2024 and the IRP took over management of the CD and has commenced the process.
3. Meanwhile, it was reported that there was settlement between the OC and the CD and based on the same, the CP was allowed to be withdrawn by our order dated 20.06.2024. Thereafter, on 14.08.2024, the Applicant/IRP filed RST.A. 52 of 2024 for restoration of the main CP

filed by the OC stating that the CD violated the terms of settlement. Hence, we ordered that the CIRP of the CD be commenced in accordance with our order dated 11.06.2024.

4. However, in this IA, the IRP submits that he was relieved of his duties as IRP, once the matter was settled with effect from 20.06.2024, and there were certain transactions and also certain defaults committed by the CD in the interregnum. It is prayed that it would be difficult for the IRP to deal with those transactions and the default committed by the CD during that period, as he was not in charge of the CD. Hence, it is prayed that the Applicant/IRP be allowed to make fresh public announcement and also to order commencement of CIRP with effect from 14.08.2024 the date on which the CP was restored on file.
5. Having heard the PCS for the IRP, we deem it appropriate to allow the IA in terms of the reliefs sought in paragraphs 30(a) to (c).
6. In the result, the **IA allowed and disposed of in terms of the above.**
