I wish to place on record my gratitude and appreciation to my esteemed Board members for their continuous support and guidance,

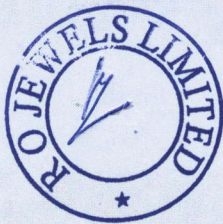
