The Punjab Produce & Trading Co. Pvt. Ltd. under Section 160 of the Companies Act, 2013 till 31st March, 2024 or until further orders, whichever is earlier.

In this context, we hereby inform the Stock Exchanges that the Hon'ble High Court at Calcutta vide Interim Order has further extended the temporary injunction restraining the Company from publishing the voting result or acting in terms of the voting result pertaining to the aforesaid matter till 30th April, 2024 or until further orders, whichever is earlier.
