बाजार में चौथे दिन गिरावट जारी, सूचकांक 58,000 के नीचे

मुंबई, 14 मार्च (भाषा)।

घरेलू शेयर बाजारों में मंगलवार को लगातार चौथे दिन गिरावट जारी रही और बीएसई सूचकांक करीब 338 अंक टूटकर 58,000 के नीचे बंद हुआ। अमेरिका में दो बैंकों के विफल होने और ब्याज दरों में बढ़ोतरी से वाहन, आइटी और वित्तीय शेयरों में गिरावट देखने को मिली।

तीस शेयरों पर आधारित बीएसई सूचकांक 337.66 अंक यानी 0.58 फीसद की गिरावट के साथ पांच महीने के निचले स्तर 57,900.19 अंक पर बंद हुआ। कारोबार के दौरान, ऊंचे में 58,490.98 और नीचे में 57,721.16 अंक तक गया।

नेशनल स्टॉक एक्सचेंज का निफ्टी भी 111 अंक यानी 0.65 फीसद की गिरावट के साथ पांच महीने के निचले स्तर 17,043.30 अंक पर बंद हुआ। इन चार दिनों में सूचकांक 2,447 अंक यानी 4.1 फीसद गिर गया। वहीं निफ्टी 711 अंक यानी 4.6 फीसद नीचे आया।

विशेषकों के अनुसार विदेशी संस्थागत निवेशकों की पूंजी निकासी जारी रहने, अमेरिकी केंद्रीय बैंक के नीतिगत दर को

लेकर फैसले से पहले निवेशकों के जोखिम वाली संपत्तियों से दूर होने और डालर के मुकाबले रुपए की विनिमय दर में गिरावट से बाजार धारणा प्रभावित हुई। सूचकांक शेयरों में महिंद्रा एंड महिंद्रा को सर्वाधिक करीब तीन फीसद का नुकसान हुआ। इसके अलावा टीसीएस, बजाज फाइनेंस, विप्रो, कोटक बैंक, टेक महिंद्रा, एचसीएल टेक और टाटा मोटर्स भी प्रमुख रूप से नुकसान में रहे।

दूसरी तरफ, टाइटेन, भारती एअरटेल, आइसीआईसीआई बैंक और एल एंड टी लाभ में रहने वाले शेयरों में शामिल हैं। इनमें 0.93 फीसद की तेजी रही।

क्षेत्रवार की बात करें तो आइटी में 1.4 फीसद, प्रौद्योगिकी में 1.08 फीसद, ऊर्जा में 1.06 फीसद, रियल्टी में एक फीसद, वाहन में 0.99 फीसद, वित्तीय में 0.54 फीसद और बैंक में 0.42 फीसद की गिरावट आई है।

सिर्फ पूंजीगत वस्तु सूचकांक 0.12 फीसद की मामूली बढ़त के साथ बंद हुआ। जियोजित फाइनेंशियल सर्विसेज के शोध प्रमुख विनोद नायर ने कहा कि बिकवाली जारी रही, जबकि अमेरिकी केंद्रीय बैंक फेडरल रिजर्व के उठाए गए कदमों से बैंकों को लेकर चीजें कुछ साफ हुई हैं। बाजार का



महत्वपूर्ण मुद्दा अधिक ब्याज दर का है, जो विश्व अर्थव्यवस्था पर असर डालती रहेगी...। रेलिगेयर ब्रोकिंग लि. के उपाध्यक्ष (तकनीकी शोध) अजीत मिश्रा ने कहा, 'बाजार पर वैश्विक गतिविधियों का असर है। हमें बुधवार को शुरुआती कारोबार में अमेरिका में मुद्रास्फीति के आंकड़ों का असर देखने को मिलेगा। बाजार में हाल की गिरावट के बाद

वालस्ट्रीट में प्रमुख सूचकांक सोमवार को नुकसान में रहे। इस बीच, अंतरराष्ट्रीय तेल मानक ब्रेट कूड 1.56 फीसद की गिरावट के साथ 79.51 डालर प्रति बैरल पर पहुंच गया। शेयर बाजार के आंकड़ों के अनुसार विदेशी संस्थागत निवेशकों ने सोमवार को 1,546.86 करोड़ रुपए मूल्य के शेयर बेचे।

इस बीच, आधिकारिक आंकड़ों के अनुसार विनिर्मित वस्तुओं, ईंधन और बिजली की कीमतों में नरमी से थोक मूल्य सूचकांक आधारित मुद्रास्फीति फरवरी में घटकर दो साल से अधिक के निचले स्तर 3.85 फीसद पर आ गई।

एशिया-प्रशांत क्षेत्र के ज्यादातर वित्तीय संस्थान अमेरिकी बैंकों के विफल होने से नहीं होंगे प्रभावित : मूडीज

नई दिल्ली, 14 मार्च (भाषा)।

एशिया-प्रशांत क्षेत्र के ज्यादातर वित्तीय संस्थानों का अमेरिकी के विफल बैंकों से कोई सरोकार नहीं है और सिलिकान वैली बैंक की तरह वे ऋण प्रतिभूति होल्डिंग को लेकर जोखिम में भी नहीं हैं।

मूडीज इन्वेस्टर्स सर्विसेस ने मंगलवार को यह कहा। उल्लेखनीय है कि अमेरिकी नियामकों ने 12 मार्च को सिग्नेचर बैंक को बंद करने का निर्णय किया। इससे ठीक दो दिन पहले सिलिकान वैली बैंक को बंद करने का फैसला किया गया था। बड़े पैमाने पर ग्राहकों के अपने जमा निकाल लेने से ये बैंक संकट में आ गए।

मूडीज ने कहा कि इन घटनाक्रमों से निवेशक सतर्क हो गए हैं, ऐसे में बुनियाभर के बांड बाजारों में नकदी का संकट खड़ा हो सकता है। हालांकि संरचनात्मक कारकों की वजह से एशिया-प्रशांत के वित्तीय संस्थानों पर इसका प्रभाव सीमित ही रहने वाला है। उसने

एक बयान में कहा, "एशिया-प्रशांत क्षेत्र के ज्यादातर संस्थानों का अमेरिकी के विफल बैंकों से कोई सरोकार नहीं है, गिनेचुने संस्थानों का मामूली रूप से लेना-देना है। अतः ज्यादातर संस्थानों को ऋण प्रतिभूति होल्डिंग्स से उतना बड़ा घाटा होने का जोखिम नहीं है जितना कि सिलिकान वैली बैंक को था।"

मूडीज ने कहा कि उसकी रेटिंग में शामिल एशिया-प्रशांत के बैंकों के पास संरचनात्मक रूप से स्थिर कोष और पर्याप्त नकदी है। उनके जमाकर्ता विविध क्षेत्रों से हैं और क्षेत्र के किसी भी बैंक का प्रौद्योगिकी कंपनियों से बहुत अधिक लेना-देना नहीं है।

इसके अलावा इस क्षेत्र के बैंकों के जमा में आमतौर पर किसी भी एकल ग्राहक का जमा बहुत अधिक नहीं होता है। उसने कहा कि क्षेत्र के ज्यादातर बैंकों का वित्तपोषण ग्राहकों के जमा से होता है, उनका बाजार उधार भी उनकी कुल परिसंपत्तियों का औसतन करीब 16 प्रतिशत है, जो बहुत अधिक नहीं है।

संसदीय समिति ने निधियों का प्रभावी उपयोग सुनिश्चित करने को कहा

नई दिल्ली, 14 मार्च (भाषा)।

संसद की एक समिति ने पिछले तीन वर्षों में कृषि एवं किसान कल्याण विभाग द्वारा 44,015 करोड़ रुपए की राशि लौटाने पर संज्ञान लेते हुए कहा है कि निधियों को लौटाने के चलन से हर तरह से बचा जाना चाहिए ताकि इन योजनाओं का वांछित लाभ प्राप्त हो सके।

भारतीय जनता पार्टी के सांसद पीसी गद्दीगौदर की अध्यक्षता वाली कृषि एवं किसान कल्याण मंत्रालय से संबंधित स्थायी समिति की वर्ष 2023-24 की अनुदान की मांगों पर रिपोर्ट में यह बात कही गई है। यह रिपोर्ट सोमवार को लोकसभा में पेश की गई।

रिपोर्ट के अनुसार, समिति के संज्ञान में विभाग के जवाब से यह बात सामने आई है कि विभाग ने वर्ष 2020-21, 2021-22 और 2022-23 में क्रमशः 23,824 करोड़ रुपए, 429.22 करोड़ रुपए और 19,762 करोड़ रुपए लौटाए। इसका अर्थ यह है कि तीन वर्षों

में विभाग द्वारा 44,015 करोड़ रुपए की राशि लौटाई गई। समिति को यह बताया गया कि लौटाई गई राशि मुख्य रूप से पूर्वोत्तर राज्यों, अनुसूचित जाति उपयोजना और जनजातीय क्षेत्रों में योजना के तहत कम जरूरत से संबंधित थी। इसमें कहा गया है कि समिति यह महसूस करती है कि हर तरह से निधियों को लौटाने के चलन से बचा जाना चाहिए ताकि इन योजनाओं का वांछित लाभ प्राप्त हो सके।

समिति ने विभाग से उन कारणों की पहचान करने की सिफारिश की है जिसकी वजह से कोष की लौटायी गयी। इसके साथ ही कोष का प्रभावी ढंग से इस्तेमाल सुनिश्चित करने के लिए उपचारात्मक कदम उठाने को भी कहा गया है। रिपोर्ट के अनुसार, समिति ने इस बात को नोट किया कि विभाग ने अपने जवाब में स्वीकार किया कि सरकार के कुल बजट की तुलना में विभाग का प्रतिशत आवंटन वर्ष 2020-21 में 4.41 प्रतिशत था जो 2023-24 में 2.57 प्रतिशत रह गया है।

मस्जिदों में लाउडस्पीकर मामले में जवाब तलब

गुजरात उच्च न्यायालय ने मस्जिदों में लाउडस्पीकर के जरिए 'अजान' देने पर रोक लगाने हेतु दाखिल जनहित याचिका पर राज्य सरकार से जवाब तलब किया है।

कार्यवाहक मुख्य न्यायाधीश ए.जे.देसाई और न्यायमूर्ति बीरेन वैष्णव की पीठ ने सोमवार को बजरंग दल नेता शक्तिसिंह जाला की याचिका को जनहित याचिका में शामिल करने की अनुमति दे दी। अदालत ने यह अनुमति मूल याचिकाकर्ता धर्मेंद्र प्रजापति द्वारा धमकी के मद्देनजर याचिका वापस लिए जाने के बाद दी।

जाला के वकील ने अदालत से अनुरोध किया कि मूल याचिकाकर्ता की अनुपस्थिति में उन्हें याचिका में शामिल होने की अनुमति दी जाए।

लोकायुक्त की याचिका पर सुनवाई के लिए सुप्रीम कोर्ट तैयार

सुप्रीम कोर्ट कर्नाटक के भाजपा विधायक की जमानत के खिलाफ कर्नाटक लोकायुक्त की याचिका पर सुनवाई के लिए मंगलवार को राजी हो गया। प्रधान न्यायाधीश धर्मेंद्र जशवंत चंद्रचूड़ की अध्यक्षता वाली पीठ के समक्ष याचिका को तत्काल सुचीबद्ध करने के लिए लोकायुक्त के वकील ने आग्रह किया था। प्रधान न्यायाधीश ने उन्हें मामले का उल्लेख न्यायमूर्ति संजय किशन कौल की पीठ से करने को कहा क्योंकि वे खुद एक संविधान पीठ में व्यस्त थे।

न्यायमूर्ति कौल ने वकील से पूछा कि

याचिका को तत्काल सुचीबद्ध करने की क्या जरूरत है? वकील ने कहा कि आरोपी मौजूदा विधायक है और उसके पास से बड़ी मात्रा में धन जब्त किया गया है। न्यायमूर्ति कौल ने तब निर्देश दिया कि मामले को जल्द से जल्द सुचीबद्ध किया जाए। उन्होंने कहा कि हाई कोर्ट ने पहले ही अपना दिमाग लगा दिया है। वकील ने अनुरोध किया कि मामले को दोपहर दो बजे सुचीबद्ध किया जाए। हालांकि, न्यायमूर्ति कौल ने कहा कि यह जमानत रद्द करने का मामला है और इसे उचित समय पर सुचीबद्ध किया जाएगा।

कर्नाटक में भारतीय जनता पार्टी के विधायक मदल विरुषक्षणा साबुन और डिटजेंट (केएसडीएल) अनुबंध घोटाले में फंसे हुए हैं।

कर्नाटक हाई कोर्ट ने मंगलवार को मदल विरुषक्षणा को पांच लाख रुपए के बांड और मुचलके पर अंतरिम अग्रिम जमानत दे दी थी। इससे पहले विरुषक्षणा के बेटे प्रशांत कुमार एमवी को लोकायुक्त अधिकारियों ने कथित तौर पर केएसडीएल कार्यालय में एक टेकेदार से 40 लाख रुपए की रिश्वत लेते हुए रंगे हाथ पकड़ा था। इसके बाद हुई छापेमारी में मदल परिचार के घर से 8.23 करोड़ रुपए नगद, भारी मात्रा में सोने और चांदी के गहने और जमीन में बड़े निवेश का पता चला था।
