Yati Narsinghanand Granted Bail by Haridwar Sessions Court

Haridwar: Hindutva-hatemonger The Haridwar Sessions Court granted Yati Narsinghanand bail in connection with the Haridwar hate speech case.

Yati Narsinghanand, the head priest of the Dasna Devi temple in Ghaziabad, Uttar Pradesh, who called for a genocide against Muslims at the Haridwar Dharam Sansad, was arrested by Uttarakhand police on January 15 for his offensive remarks about women. The priest of the Dasna temple was later charged with hate speech and abusing a journalist by the police.

He was then placed in judicial custody for 14 days. His bail application was denied by the Chief Judicial Magistrate (CJM) of a court in Haridwar on January 19. Narsinghanand has been arrested in connection with the Dharma Sansad case and booked under IPC sections 295 (A) (deliberate and malicious acts intended to outrage religious feelings of any class by insulting its religion or religious beliefs) and 509 (word, gesture, or act intended to insult the modesty of a woman).
