Allahabad North seat : Congress in trouble

Prayagraj : The Congress leadership was in a bind after UPCC general secretary and senior party leader Mukund Tiwari purchased nomination forms to contest from the Allahabad North assembly seat. In the first list of candidates released by the party headquarters, former MLA Anugrah Narayan Singh was named as the party's candidate for Allahabad North assembly seat. While the leaders of district and city Congress



committees remained tight-lipped about the situation, even claiming ignorance, Tiwari stated, "I, as a true party worker and a five-time corporator

of Allahabad North Assembly Constituency. I have been working in Congress for a long time and have even been elected as a corporator for five terms," Mukund said, adding, "I have held important positions in the youth Congress as well as the UPCC and have participated in all party events for the past 25 years." He is keeping fingers crossed and likely to contest as an independent candidate this time.

Yati Narsinghanand Granted Bail by Haridwar Sessions Court



Haridwar : Hindutva-hatemonger The Haridwar Sessions Court granted Yati Narsinghanand bail in connection with the Haridwar hate speech case. Yati Narsinghanand, the head priest of the Dasna Devi temple in Ghaziabad, Uttar Pradesh, who called for a genocide against Muslims at the Haridwar Dham Sansad, was arrested by Uttarakhand police on January 15 for his offensive remarks about women. The priest of the Dasna temple was later charged with hate speech and abusing a

journalist by the police. He was then placed in judicial custody for 14 days. His bail application was denied by the Chief Judicial Magistrate (CJM) of a court in Haridwar on January 19. Narsinghanand has been arrested in connection with the Dharma Sansad case and booked under IPC sections 295 (A) (deliberate and malicious acts intended to outrage religious feelings of any class by insulting its religion or religious beliefs) and 509 (word, gesture, or act intended to insult the modesty of a woman).

More than 12.07 Crore balance and unutilized vaccine doses still available with States/UTs

New Delhi : Ministry of health and family welfare claimed that More than 12.07 Crore vaccine doses still balance and unutilized still available with States/UTs. The union Government have been provided to States/UTs than 167.84 crore (1,67,84,78,485) vaccine doses so far. These all are through free of cost channel and through direct state procurement category.

In a statement, health ministry says that centre government is committed to accelerating the pace and expanding the scope of COVID-19 vaccination throughout the country. The nationwide COVID 19 vaccination started on 16th January 2021. The new phase of universalization of COVID-19 vaccination commenced from 21st June 2021. The vaccination drive has been ramped up through availability of more vaccines, advance visibility of vaccine availability to States and UTs for enabling better planning by them, and streamlining the vaccine supply chain.

Army man arrested with brother for killing wife

Prayagraj : Kokhraj police in Kaushambi district claimed to have solved the murder of a 38-year-old woman by arresting her husband (an army man) and brother-in-law. The accused duo allegedly murdered the woman and later claimed that she fled home with cash and jewellery. The woman's body was discovered by police on Monday. According to reports, Savitri Devi aka

Radha, 38, a resident of Barkatpur village, went missing recently under suspicious circumstances. Kunwar Singh, a UDC at New Cantonment in Prayagraj, claimed in a police complaint filed on February 1 that his wife had left home with Rs. 50,000 in cash and jewellery.

He questioned her having illicit relationships and accused his in-laws of assisting her in fleeing the country. The police filed a missing persons report and began an investigation. Kunwar was apprehended by police and questioned, during which he confessed to killing his wife. Ganesh Prasad, SHO of Kokhraj police station, stated that the accused and his brother strangled the woman with an

electric wire and drove her body to Sandipan Ghat in his car. The body was buried first, but the duo returned the next day and burned it. The police recovered the woman's burned body and sent it for an autopsy.

The accused's interrogation revealed that Kunwar and his wife were having estranged relationship. Kunwar was recently ordered by the court to pay Rs.10,000 in expenses to his wife each month. Savitri and her three children used to live in a rented room in Prayagraj. Kunwar lured her to his home on January 30 under the guise of a compromise, but then murdered her. According to police, the accused was hesitant because he wanted to marry another woman.

To win elections many candidates willing to contest from anywhere

Prayagraj : This time, the poll scene in Prayagraj region is a saga of contrasts. Some candidates have entered the electoral fray from their traditional seats, while many others, in their bid to be elected, are always willing to contest from anywhere, regardless of their political home turf. For example, Anugrah Narayan Singh of the Congress Party is contesting for the 10th time in last 37 years from his traditional Allahabad North assembly seat, and Raghuraj Pratap Singh is running

for the seventh time in 29 years from Kunda in Pratapgarh. Vachaspati, the Apna Dal (Sonelal) candidate from Bara, has previously contested assembly elections from different seats. In 1996, he contested election on a Bharatiya Janata Party (BJP) ticket from the Manjhanpur seat of Kaushambi, but was defeated by the Bahujan Samaj Party's Indrajeet Saroj. He won the assembly elections in 2007 from the Sirathu seat in the Kaushambi district. However, in

2012, he contested as an independent candidate from the Soran seat and finished third. In 2014 by-elections, he ran from Sirathu again and won, this time as a Samajwadi Party (SP) candidate. In 2017, he contested from the Sirathu seat again as an SP candidate, but lost to BJP candidate Sheela Prasad. Both state cabinet minister and BJP candidate from Allahabad West Sidharth Nath Singh and deputy chief minister and BJP candidate from

Sirathu seat of Kaushambi Keshav Prasad Maurya would be unable to vote for themselves because their names are on the voter list of Allahabad North. Similarly, Apna Dal (S) leader Nagendra Singh Patel, who is running for the Chail seat in Kaushambi district, lives in Phulpur. Pooja Pal, the SP candidate from Chail, is on the voter list of Allahabad West, and Sandeep Singh, the SP candidate from Meja, lives in Bara and is also on the voter list of Bara.
