In receipt of your letter 186215/DOC/ISR-I/65073 Dated 25.03.2023 I happy to know that the KYC in respect of Folio No. 01/25815 has been updated.

I would like to state that in my said letter I had also written about replacement / re-issue of certificate No. 1543 for 2000 equity shares. This aid certificate for 2000 equity shares was lodged for dematerialisation in 2021, but it was returned because the certificate turned invalid as it was issued prior to the year 2005. Hence, it needs to be replaced, but I am surprised that you ignored the issue of replacement of share certificate no. 1543 in your reply.

Similarly, the Company issued 3000 bonus equity shares in my favour in the year 2016, but the said share certificates never reached me. I apprehend that said share certificates for 3000 equity shares are either returned to your office or has been wrongly delivered by the postal department.

With regards to the above, I request you to kindly let me know the duplicate process and required formalities that need to be done.


