India reports 27,071 new Covid-19 cases; 336 deaths in last 24 hours

New Delhi India on Monday reported 27,071 new Covid-19 infections, taking the country's total to 98,84,100. With 336 new deaths, the toll mounted to 1,43,355 as of Monday, with total active cases at 3,52,586.

The total discharged cases are at 93,88,159 with 30,695 new discharges in the last 24 hours.On Sunday, Delhi recorded 1,984 fresh Covid-19 cases which pushed the infection tally to 6.07 lakh, while the death toll crossed the 10,000 mark with 33 new fatalities. These fresh cases came out of 72,335 tests conducted the previous day, including 35,611 RT-PCR tests, according to the latest bulletin issued by the Delhi health department. With over 98.57 lakh total coronavirus cases, India's active caseload continues to decline and is currently below 3.6 lakh, the union ministry of health said on Sunday. India on Sunday reported 30,254 new coronavirus cases taking the country's total to 98,57,029, as per the Union Health

BJP activist found dead near his home in West **Bengal's East Burdwan** district

New Delhi ABJP activist was found dead near his home in West Bengal's East Burdwan district on Sunday.Sukhdeb Pramanik's body was retreived from a pond in Purbasthali area and has been sent for post mortem now, police said, news agency PTI

Though police did not confirm Sukhdeb Pramanik's political affiliation, his family and the BJP said he was associated with the party.His family claimed that Pramanik went missing after participating in a BJP rally two days ago. Reacting to the incident, the BJP said it will hit the streets in Purbasthali area on Monday, demanding "immediate punishment for his assailants".

Local TMC leaders, however, accused the saffron party of trying to "politicise every unnatural death" ahead of assembly elections, likely to be held in April-May next year.Pramanik's death comes a day after another BJP worker, Saikat Bhawal, was killed in an attack in North 24 Parganas.

Kanpur: Army colonel slips sedative in friend's drink, rapes his Russian

Kanpur An Army colonel posted in Kanpur was booked on Sunday for allegedly raping a friend's wife, a Russian national, at an officers mess.

The victim's husband, a civilian, lodged an FIR against the Army officer at the Cantonment Police Station. According to the complainant, his wife is of Russian descent and has been living in India for 10 years.In the complaint, victim's husband said that the colonel had invited his wife and him to a party on the occasion of his



promotion to the rank of colonel from that of lieutenant colonel on Saturday, Superintendent of Police (East) Raj Kumar Agarwal.Agarwal added that police have launched a probe and efforts are being made to nab the colonel. Accused's friend has alleged that he was offered an intoxicating drink which made him unconscious, after which the accused raped his wife.

The accused also allegedly assaulted the woman when she put up a resistance.

A case has been registered under various sections of the Indian Penal Code (IPC) and several police teams have been formed to nab the accused.

Himachal Pradesh **Governor Bandaru** Dattatreya meets with an accident in Telangana, escapes unhurt

New Delhi Himachal Pradesh Governor Bandaru Dattatreya had a miraculous escape as the car in which he was travelling veered off near Choutuppal on outskirts of Hyderabad on Monday (December 14)

The Governor was going towards Nalgonda district near Hyderabad in Telangana.

Governor's private secretary confirmed to Zee news that Bandaru Dattatreya was travelling in the ill-fated car. However, the Governor is safe and he proceeded towards his destination in another vehicle.Himachal Pradesh Governor Bandaru Dattatreya met with an accident today near the Choutuppal town in the Yadadri Bhuvanagiri district of Telangana. No casualties or injuries have been reported," K Narayana Reddy, DCP Bhongir, told ANI.

Hyderabad: 4 killed as speeding lorry rams into car at Gachibowli area

Five people were killed on Sunday when a tipper lorry rammed the car they were travelling in at Gachibowli area in Hyderabad on Sunday. The accident took place in the wee hours at around 2:45 am on Sunday.

signal. The car took a right turn when the lorry coming from the opposite direction rammed it, killing four people on the spot.

Another man succumbed to his injuries at a hospital. The lorry driver, meanwhile, sustained simple injuries. The deceased, all of whom are natives of Andhra Pradesh, have been identified as K Santhosh(25), K Pavan Kumar(24), Chinta Manohar(23), P Bharadwaj(20) and N Roshan(23).

They were reportedly residing in a men's hostel facility in Madhapur, while working in a private company in Hyderabad. During the time of the accident, they were travelling from Indian Institute of Information Technology-Hyderabad (IIT-H) road to Gowlidoddi, police said.Gachibowli Circle Inspector Srinivas said investigation is on to ascertain whether the accident occurred due to human error or were there any other issues that

need to be considered, reports said.

We are investigating the issue to see if it was due to human error or any other technical issues. We have also checked the tipper vehicle and have collected the blood samples of the lorry driver to see if there was any alcohol consumption. However, the samples of the dead were not checked yet for alcohol consumption," he said.

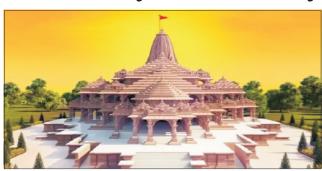
Ram Mandir in Ayodhya will be built with donation of public and not with government money - Here's how you can donate

Thousands of iPhones looted at Wistron's Kolar plant, company suffers loss of Rs 440 cr in violence

New Delhi After Saturday's violence at Wistron's plant in Karnataka's Kolar, the company said it suffered a loss of Rs 440 crore as thousands of iPhones were looted.

The company said this in its complaint to the police and the labour department, reported The Times of India. The workers at the factory which manufactures iPhones went on a rampage and pelted stones at the factory over the non-payment of salaries. The factory is located at Narasapura in Kolar district.

Police have said that the employees at the facility in the Narasapura Industrial Area of Kolar district rampaged through the factory, damaging furniture besides other things over non-payment of salaries. The employees, who had been protesting over the salary dues, alleged that they have not been paid for the past four months.

According to PTI, workers pelted stones, "smashed glass windows,

damaged vehicles, furniture, computers, and laptops in connection with salary-related issues". Speaking to India Today TV, Kolar SP Karthik Reddy said, "The employees vandalised the factory around 6:30 am. A lot of property has been destroyed. We are still investigating what led to it.""They work in two shifts. There are about 7-8,000 workers. We have just been able to disperse the mob with lathicharge. Two vehicles to move things within premises were brunt. We are trying to identify the miscreants," he said. The Karnataka government condemned the incident of violence at Wistron's factory in Narasapura, Kolar.

Deputy Chief Minister CN Ashwathnarayan said, "Have spoken to the SP, Kolar to ensure that all measures are taken to bring the situation under immediate control and the culprits are identified. Strict action will be taken under the law against the errant elements
